NOTICE TO SUPPLEMENT FILE

On July 26, 1999, Terre Du Lac Utilities Corporation (Company), filed revised tariff sheets pursuant to an agreement between the Company and the Commission's Staff for a rate increase pursuant to the Commission's Small Company Rate Increase Procedure under 4 CSR 240-2.200. The Company initiated the rate increase request on October 26, 1998.

The revised tariff sheets filed on July 26, 1999, do not have the issue date or effective dates completed. These items are required. 4 CSR 240-50.010(2) and (3). Before the Commission can act on this request, substitute tariff sheets must be filed by the Company with these dates completed, and showing an effective date of not less than forty-five days from the issue date.

In addition, the Staff and the Company were not able to reach an agreement within 150 days from the date the Company initiated this procedure. Therefore, a written consent for an extension between the Company and Staff should be filed with the substitute tariff sheets in order for the Commission to proceed pursuant to 4 CSR 240-2.200(1)(G).

Finally, the dates for the Office of the Public Counsel to request a public hearing (20 days from filing the tariff sheets) or to notify Commission Staff that OPC agrees or disagrees with the tariff

sheets (25 days from filing the tariff sheets) shall run from the filing dates of the substitute tariff sheets.

The Commission will take no further action until the Company and Staff comply with this notice.
