## NOTICE CLOSING CASE

On June 29, 1998, the Commission issued Supplemental Order No. 52 in Case No. 11,110. By virtue of that order, the Commission made its public utility assessment against public utilities provided for by § 386.370 RSMo for the Commission's fiscal year commencing July 1, 1998. Subsequently, a group of public utilities filed an Application for Rehearing and Stay alleging errors in the manner the assessment amount was determined. The Commission established this case to address the issues raised in the Application.

The parties in this case filed a Stipulation of Facts in lieu of an evidentiary hearing. The Commission held a hearing for the purpose of oral argument on October 14, 1998 and issued its Report and Order on December 17, 1998. On February 17, 1999, the Commission issued an Order Denying Rehearing upon the public utilities' request. Since no party sought review by the circuit court, the Report and Order became final on March 20, 1999. Therefore, this case may be closed.
