FACTUAL BACKGROUND: (Events Giving Rise to Cause of Action)

The Missouri Public Service Commission issued a Report and Order in Commission Case No. ER-2012-0166, on December 12, 2012, effective December 22, 2012. In that Report and Order, the Commission approved a rate increase for Appellant Union Electric Company of approximately \$260 million annually. The Commission also approved the inclusion in the Fuel Adjustment Charge of certain expenditures that Ameren Missouri remits to the Midwest Independent System Operator. This inclusion is unlawful in violation of Section 393.135 RSMo 2000 and Section 386.266.1, RSMo 2000.

Public Counsel timely filed an Application for Rehearing of the Report and Order, which the Commission denied on January 3, 2013.

ISSUE(S): (Anticipated to be Presented by the Appeal; Appellant is Not Bound by this Designation)

Whether the Commission's decision to allow the Midwest Independent System Operator charges to flow through the Fuel Adjustment Charge was lawful.
