NOTICE OF CHANGE APPLICATION

COMES NOW Cable One, Inc. d/b/a Sparklight ("Cable One"), pursuant to § 67.2679 RSMo, to submit its application to expand video service to additional political subdivisions and to provide notice of changes to the Missouri Public Service Commission ("Commission"), and states as follows:

1. Cable One is a publicly traded Delaware corporation with headquarters located at 210 E. Earll Drive, Phoenix, Arizona 85012. Cable One and its subsidiaries provide video, Internet access, broadband, and voice services in 24 states, including Missouri. In Missouri, Cable One holds authority to provide video service (ID 3835) and is registered as an interconnected Voice over Internet Protocol ("VoIP") service provider (ID 6833).

2. Cable America Missouri, LLC ("Cable America") is a Delaware limited liability company. In Missouri, Cable America holds authority to provide video service under ID 4006.

3. On October 8, 2021, Cable America, Cable America Properties, LLC, and Cable One entered into an Asset Purchase Agreement ("Agreement"). Pursuant to the Agreement, Cable One acquired certain customer accounts and receivables, customer agreements and contracts, vendor agreements and contracts, equipment, and

intellectual property assets from Cable America and Cable America Properties, LLC (the "Transaction"). Cable One, however, did not assume any of Cable America's pre-closing liabilities or obligations.

4. The Transaction was consummated effective December 30, 2021. Accordingly, all video customers served by Cable America in Missouri will now be served by Cable One. All former Cable America customers will receive notice that their service will be provided by Cable One under its Sparklight brand going forward.

5. Pursuant to the Transaction, Cable One will now provide video service in the following political subdivisions, which previously were served by Cable America pursuant to its Video Service Authorization:


