MOTION TO TAKE CASE UNDER SUBMISSION

Comes now Adelphia Business Solutions Operations, Inc. ("Adelphia"), by and through counsel and pursuant to 4 CSR 240-2.115, and for its Motion To Take Case Under Submission, respectfully states as follows:

1. On October 14, 1999 the Commission issued its Order Granting Intervention, Setting A Prehearing Conference, And Directing Filing of Procedural Schedule wherein, *inter alia*, the Commission set an early prehearing conference for November 23, 1999, directed the parties to file a proposed procedural schedule on or before November 30, 1999, and noted that the Commission could grant the service authority requested without a hearing if no party requested same.

2. Adelphia, the Staff and Intervenor Southwestern Bell Telephone Company have this date filed a Joint Stipulation and Agreement in this case. The Office of the Public Counsel, while not a signatory to the Stipulation and Agreement, has indicated no opposition and is not expected to request a hearing pursuant to 4 CSR 240-2.115.

3. As such, this case should be ready for decision without the need for further proceedings and Adelphia therefore requests that the Commission simply take the case under submission.

WHEREFORE, Adelpia Business Solutions Operations, Inc. respectfully moves the Commission to take this case under submission without the need for further proceedings.
