MOTION FOR LEAVE TO AMEND APPLICATION

Comes now @link Networks, Inc. ("@link" or the "Company") and pursuant to 4 CSR 240-2.080(21) moves for leave to amend its application in the referenced matter. In support thereof, the Company submits the following:

1. Since the time the Company's application was filed in this case, several rules of the Commission have been revised or rescinded and the list of waivers requested by the Company in its application are now out of date. Accordingly, @link requests leave to amend paragraph 15 of its application by interlineation to reflect the statutes and rules, as they have been revised, for which the Company requests waiver.

2. The Company asks leave to amend paragraph 15 of its Application so that it should hereafter read as follows:

15. @link will comply with all applicable statutes and Commission rules, regulations, decisions, and orders governing the provision of @link's proposed services. @link, however, requests that, at a minimum, the following statutes and regulations be waived at this time consistent with the Commission's previous decisions regarding other telecommunications providers:




