MOTION TO CORRECT DEFICIENCY

Come now Spectra Communications Group, LLC, ("Spectra") and Mark Twain Communications Company ("Mark Twain") (hereinafter sometimes referred to as "Joint Applicants") and for their Motion to Correct Deficiency state to the Missouri Public Service Commission ("Commission") as follows:

1. On February 24, 2000, Joint Applicants filed with the Commission a Joint Application requesting approval of an interconnection and unbundling agreement between the two parties.
2. On March 7, 2000, the Commission issued a Notice of Deficiency wherein the Commission stated that the Joint Applicants had not complied with Commission rule 4 CSR 240-2.060(1)(A) in that the parties had not included in the application the street and mailing address of the principal office or place of business of the applicants.
3. Joint Applicants were directed to comply with Commission rule 4 CSR 240-2.060(1)(A) by March 17, 2000.
4. Spectra's street and mailing address of its principal office and place of business is 8800 Blue Ridge Blvd., Suite 100, Kansas City, MO 64138. Mark Twain's street and mailing

address of its principal office and place of business is Hwy. 6 East, Hurdland, MO 63547.

Whereas Joint Applicants respectfully request that the Commission accept the above information to correct the deficiency in their Joint Application and for any other relief appropriate in the circumstances.
