## MOTION TO SUSPEND THE STAFF RESPONSE

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its Motion to Suspend the Staff's Response states as follows:

- 1. On November 3, 2000, @link Networks, Inc. ("Applicant") filed a proposed tariff with the Commission. The Commission issued its *Order Directing Filing* on November 7, 2000 and directed the Staff to respond to Applicant's proposed tariff "whether a memorandum and recommendation or a motion to suspend or to reject, on or before November 24, 2000."
- 2. On November 13, 2000, the Applicant filed a letter withdrawing the proposed tariff. The Applicant has not filed a new proposed tariff with the Commission.

WHEREFORE, the Staff respectfully requests that the Commission suspend the Staff Response to the proposed tariff until after the Applicant files a new proposed tariff in this matter.
