MOTION TO CANCEL REGISTRATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the registration of NPG Digital Phone, Inc. ("Company") to provide interconnected voice over internet protocol service in the State of Missouri. For its Motion, Staff respectfully states as follows:

- 1. On October 30, 2008, the Commission granted NPG Digital Phone, Inc. authority to provide interconnected voice over internet protocol services in certain exchanges in the state of Missouri in Case No. DA-2009-0119.
- 2. In July 2012, the undersigned spoke with a representative of the Company that stated NPG Digital Phone, Inc. merged with NPG Digital Phone, LLC, with the LLC being the surviving entity, and that NPG Digital Phone, Inc. was no longer serving customers in Missouri.
- 3. The Missouri Secretary of State's ("SOS") website contains documents related to the merger, including the Articles of Merger executed April 1, 2011, and the Missouri SOS Certificate of Merger effective April 1, 2011. (See Attachment A).
- 4. Because NPG Digital Phone, Inc. is no longer providing service in Missouri, the Staff recommends the Commission cancel the Company's registration.
- 5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex

Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

6. The Company is delinquent on the filing of its calendar year 2011 annual report.

WHEREFORE, Staff recommends the Commission cancel the registration of NPG Digital Phone, Inc. to provide interconnected voice over internet protocol service in the State of Missouri.
