MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through Counsel, and moves for the Missouri Public Service Commission (Commission) to cancel Greg Elson's (Mr. Elson) certificate of service authority to provide private pay telephone service in Missouri, via customer-owned pay telephone (COCT) equipment. For its Motion, Staff respectfully states the following:

- On April 19, 1999, the Commission issued its Order in Case Number TA-99-407, granting a certificate of service authority to Mr. Elson to provide private pay telephone service in Missouri, via COCT equipment. See Attachment A.
- 2. On January 22, 2008, the Commission's Budget and Fiscal Services Department received a letter from Mr. Elson stating "[p]lease update your records to show that I am no longer the Owner of Robo Wash Laundry and all services connected with the business. The sale of the business was during the month of September, 2006." See Attachment B.
- 3. Mr. Elson reported zero revenue on his statement of revenue for years 2005 and 2006.
- 4. Mr. Elson owes no past assessments to the Commission.
- 5. Pursuant to 4 CSR 240-3.505(1)(B), COCT providers are exempt from the Section 392.390.1 RSMo (2000) requirement to file annual reports.
- 6. On July 15, 2008, Counsel for Staff contacted Mr. Elson, who stated he sold his laundry business in September of 2006, all payphone equipment was included in the sale, and he no longer provides any regulated intrastate services to customers in Missouri.

- Because Mr. Elson has requested cancellation of his certificate and is not providing services in Missouri, Staff recommends the Commission issue an order canceling his certificate.
- 8. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo (Supp. 2007), which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 9. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificate of service authority of Greg Elson, to provide private pay telephone service in Missouri, via customer-owned pay telephone equipment.

ORDER GRANTING CERTIFICATE OF SERVICE AUTHORITY TO

PROVIDE PRIVATE PAY PHONE SERVICES

On March 24, 1999, Greg Elson (Applicant) filed an application with the Missouri Public Service Commission pursuant to Section 392.440, RSMo 1994 for a certificate of service authority to provide private pay telephone service in Missouri, via customer-owned pay telephone (COCT) equipment. Applicant is an individual doing business under his own name with his principal place of business located at 333 E. Clayton, Brookfield, Missouri 64628.

The Commission issued an Order and Notice on March 25 that set an intervention deadline of April 9. No applications to intervene were filed. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based upon the verified application.

The Commission finds that competition in the private pay telephone service market is in the public interest and that Applicant should be granted a certificate of service authority. The provision of private pay telephone service is classified as competitive and subject to minimum regulation pursuant to Section 392.520. specifically exempts COCT providers from the tariff Sections 392.220, RSMo requirements of Supp. 1998, 392.230, 392.370.4, 392.370.5, and 392.500. Applicant shall notify the

- Commission if he ceases to provide private pay telephone services in the state of Missouri, or if the address or phone number of his principal place of business changes. The Commission finds that Applicant's service shall be provided in accordance with the following requirements:
 - A. The equipment shall provide users access to the following without charge and without the use of a coin: (i) dial tone; (ii) an operator; and (iii) local 911 or E-911 emergency service, or, where unavailable, prominently displayed instructions on how to reach local emergency service;
 - B. The equipment shall be mounted in accordance with all applicable federal, state, and local laws for the disabled, and shall provide access to telecommunications relay service calls for the hearing disabled at no charge to the caller;
 - C. The equipment shall allow completion of local and long distance calls;
 - D. The equipment shall permit access to directory assistance;
 - E. There shall be displayed in close proximity to the equipment, in 12 Point Times Bold print, the address, and telephone number COCT provider, the procedures for reporting service difficulties, the method of customer refunds, and the method of obtaining long distance access. If applicable, the notice that only one-way calling shall state permitted. If an alternative operator services (AOS) provider is employed, the COCT provider shall display such notice as is required by the Commission; and
 - F. The equipment shall not block access to any local or interexchange telecommunications carrier.

IT IS THEREFORE ORDERED:

1. That Greg Elson is granted a certificate of service authority to provide private pay telephone service in the state of Missouri via customer-owned pay telephone equipment, subject to the requirements of certification set out in this order.

- 2. That this order shall become effective on April 29, 1999.
- 3. That this case may be closed on April 30, 1999.
