## NOTICE OF WITHDRAWAL OF TARIFF FILING

Primus Telecommunications, Inc. ("PTI") and Least Cost Routing, Inc. ("LCR," together "Applicants"), through undersigned counsel and pursuant to 4 CSR 240-2.080, hereby withdraw PTI's Adoption Notice and Revised Title Page to the existing tariff of Least Cost Routing, Inc. (establishing PTI's Tariff Mo P.S.C. No. 3, and constituting the above-referenced Tariff Tracking No. YX-2008-0367), which were scheduled to be effective January 11, 2008.

- 1. As referenced in the Commission's Order Approving Joint Application and Approving Tariff ("Order") entered in this matter on December 20, 2007 and effective January 11, 2008, on December 19, 2007, the Applicants withdrew their request for expedited treatment of the subject tariff filing "stating that due to multi-jurisdictional issues they did not want the tariffs to be approved to become effective prior to the original January 11, 2008 effective date." (Order, page 2).
- 2. In their withdrawal of request for expedited treatment, Applicants also advised the Commission that to the extent the internal reorganization approval in other jurisdictions is delayed beyond the January 11, 2008 date, Applicants would further extend the effective dates

prior to January 11, 2008. Applicants hereby advise the Commission that all requisite state regulatory approvals will not be obtained in time to permit a January 11, 2008 closing of the merger transaction. Accordingly, whereas the Commission's Order approved the proposed tariff sheets submitted by PTI to become effective on and after January 11, 2008, Applicants hereby withdraw said tariff sheets prior to their effective date. As soon as possible, PTI will re-file said tariff sheets with the requisite 30-day effective dates to conform to the anticipated closing date of the transaction approved herein.
