**ORDER OPENING A WORKING CASE AND SCHEDULING A WORKSHOP TO
CONSIDER PROPOSED AMENDMENTS TO MANUFACTURED HOUSING RULES**

On December 30, 2015, the Director of the Manufactured Housing and Modular Units Program filed a motion asking the Commission to open a working case to assist the Director in collecting comments and suggestions from interested stakeholders before beginning the formal rulemaking process to amend the Commission's existing manufactured housing rules. The Director also asks the Commission to schedule a rulemaking workshop to facilitate discussion about the proposed rule amendments. The Commission will grant that motion.

This file will serve as a repository for documents and comments. Using this file, any person with an interest in this matter may view documents and may submit comments or documents. As this is not a contested case, anyone may file a comment without legal counsel and without *ex parte* constraints. Intervention requests are not necessary to submit comments or view documents.

3. The Director of the Manufactured Housing and Modular Units Program shall present his findings regarding the proposed rule amendments at the Commission's scheduled agenda meeting during the week of February 14, 2016.
4. This order shall be effective when issued.
