COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion states:


1. On June 4, 1997, Southwestern Bell Telephone Company (SWBT) and Ameritech Mobile Communications, Inc. (Ameritech) filed their Joint Application for Approval of Interconnection Agreement between SWBT and Ameritech.
2. On June 9, 1997, the Commission issued an Order and Notice.
3. On June 30, 1997, the Small Telephone Company Group, Fidelity Telephone Company, and Bourbeuse Telephone Company (collectively referred to as STCG) filed an Application to Participate.
4. On July 21, 1997, the Commission adopted an Order Granting Participation.
5. On July 23, 1997, the Commission issued a Notice of Correction.
6. On August 4, 1997, STCG filed Comments Regarding Approval of Interconnection Agreement.
7. On August 11, 1997, SWBT filed a Reply.
8. On August 14, 1997, Staff recommended that the Commission direct SWBT and Ameritech to Amend the Interconnection Agreement.

9. On August 19, 1997, the Commission issued a Notice of Hearing.
10. On August 22, 1997, SWBT and Ameritech filed an Amendment by Interlineation of Agreement for Interconnection.
11. On August 22, 1997, Staff recommended that the Commission approve the Amendment to the Interconnection Agreement.
12. On August 25, 1997, entries of appearance were filed.
13. On August 27, 1997, the Commission adopted an Order Approving Interconnection Agreement and requiring SWBT and Ameritech to file a copy of the agreement with Staff.
14. On November 7, 1997, SWBT and Ameritech filed a copy of the Interconnection Agreement.

WHEREFORE, the Staff requests the Commission to close Case No. TO-97-523.
