My name is Susan Inskeep and I am one of the Kansas landowners affected by the transmission project in Kansas. I don't know what you have heard and I can't possibly express all that has happened but I must say none of it has been transparent. Two years before landowners even knew this was happening, Gov. Brownback placed Mark Sievers as the Chairman of the KCC. Grain Belt was given public utility status then. After notifying landowners in late July, this was pushed through so fast that even when the negative comments were four times the positive ones on the KCC website, Sievers reported after their decision to ok the siting, there was overwhelming support. ## Grain Belt Express Clean Line Files for Negotiated Rate Authority at FERC 11/20/2013 <br> 0 Comments

One of the biggest questions plaguing Grain Belt Express opponents has at long last been answered... well, sorta, for now.

Who is supposed to pay for this $\$ 2$ billion project?
By finally applying to the Federal Energy Regulatory Commission for authority to negotiate rates for transmission service with potential buyers and sellers of electricity, Grain Belt Express pretends that it intends to finance its own project.

Although, GBE has been telling other audiences that ratepayers in "states farther east" may be paying for its project:
Mr. Glotfelty also noted that there could be circumstances under which the Grain Belt Project could find it necessary to depart from the cost recovery model described and instead seek cost recovery through regional or inter-regional cost allocation mechanisms.

Mr. Berry testified that while Petitioner currently has no plans to seek cost recovery for this Project through regional cost allocation, Petitioner is not in a position to make an irrevocable commitment not to seek cost allocation. He stated that such a commitment would be premature and would potentially go against the public interest. If regulations change in the future, an irrevocable commitment not to recover costs in a certain manner may compromise the ability of Petitioner to complete the Project.
Do you think maybe GBE isn't being completely honest with FERC? I do wonder how a situation that may compromise GBE is is against the public interest, if all project risk is being absorbed by GBE as a merchant transmission project?

GBE has presented an altered version of reality to FERC:
D. Public Outreach

Public outreach and active stakeholder involvement are key components of Applicant's approach to development of the Project. Beginning in 2010, Grain Belt Express implemented an extensive, methodical, multi-level public outreach strategy across Kansas, Missouri, Illinois, and Indiana, which has resulted in more than 1,000 in-person meetings across the Project area as of November 2013. Grain Belt Express also has maintained an active presence online and through social media. The Project's website, www.grainbeltexpresscleanline.com, has been actively updated since the beginning of the Project in 2010. Among other information, the website contains: a project video that describes the need for the Project and how Grain Belt Express will bring significant economic benefit to states through much-needed transmission expansion for new wind energy projects; an FAQ section for all stakeholders to learn greater details about the Project; a section on how local businesses can learn about opportunities to participate in
the construction of the Project; and information regarding Project meetings, maps, studies, regulatory filings, and third-party resources. In addition, Grain Belt Express distributes a newsletter on a regular basis to hundreds of stakeholders. These newsletters provide information on Project milestones, recent events and meetings, as well as upcoming Project activities. The newsletter is available to anyone who is interested in receiving a copy. Applicant's participation in multiple state regulatory proceedings also has publicized information regarding the Project.

## E. Project Schedule

Applicant continues to work closely with land use and routing experts as well as landowners, local government officials, state and federal agencies, and other stakeholders in the areas where the Project will be built in order to gather input and determine the specific route for the transmission line in each state that it will traverse. Applicant is consulting experts on topics such as threatened and endangered species, archaeology, and cultural resources to ensure that appropriate considerations are taken into account in the routing decisions. Applicant expects to obtain all necessary authorizations from federal, state, and local governments and agencies for the Project by 2016.
I think I might know a few landowners who feel they have not been "closely worked with." In fact, the affected landowners in Kansas were the LAST ones to find out about GBE's project. Some of these landowners feel they were not properly notified under Kansas law, and even when they found out, they were denied effective participation in a matter that granted GBE the right to take their land by force. GBE even admits that, according to their public outreach plan, landowners are the last to be notified, after environmental groups, business groups, elected officials, local governments, and potential suppliers. It is only after Clean Line has drummed up support for its project by schmoozing and making dubious promises that it springs the project on affected landowners. In this way, Clean Line hopes that landowner concerns will be smothered by the group of MIMPSYs it has created.

However, FERC has no jurisdiction to right any wrongs made in the state regulatory process because it has no authority over siting and permitting. But, the dishonesty is galling.

GBE also tells FERC that it will shoulder all financial responsibility and risk for its project:
Applicant is assuming all market risk associated with the development and construction of the Project, and Applicant does not have and will not have any captive customers. Accordingly, Applicant has no ability to pass through the Project's costs to captive ratepayers.
Well, not really. GBE is passing some of its risk and cost associated with its project on to affected landowners and local governments who are expected to shoulder uncompensated project costs. Such costs may include the expense of providing public safety services during construction and operation, use of roadways for construction and maintenance, reduction in tax base, lowered property values, interference with farming operations, health and safety risks of living and working in close proximity to the project, inverse condemnation takings, lowered farm operation income, and increased costs to farm around the project, and the list goes on.

GBE also mentions that there are other planned regional projects that will provide price competition. These other projects that are ordered by RTOs are financed by, and guaranteed cost recovery from, ratepayers. Ratepayers are assuming all risk of these other projects. If GBE causes the competing projects to fail, ratepayers will end up financing the failed projects, for which they will never receive any benefit.

In addition, GBE is promising FERC that it will abide by the Commission's rules about honest and aboveboard negotiation with potential customers. If landowners believe GBE has not been honest and aboveboard with them, how can FERC trust that GBE will keep promises made in this application? Many believe that GBE has not developed a good reputation of honestly attempting to follow regulation in the public interest. In fact, some believe that GBE's reputation is that of smart alec arrogance, always trying to manipulate regulation in order to advance its pecuniary goals.

For instance, after promising Kansas regulators 135 "operations" jobs in the state related to its project, GBE tells FERC the truth:

Once the Project is completed, Applicant will turn over operational control of the Project to an RTO, which will operate the line pursuant to a FERC-approved non-discriminatory rate schedule filed under the RTO's OATT.

## There is no RTO located in Kansas.

GBE also asks FERC for permission to use special selection criteria to evaluate offers. Preference will be given to potential customers who are willing to make "deposits" and shoulder some of the cost burden. In this way, GBE may be discriminating against customers who are not in a position to invest in its speculative project. I'm not sure this is what FERC really had in mind as non-discriminatory.

Keep an eye on this one. It's going to be interesting.

## Dear Commissioner Stoll,

I live in Clinton County Missouri and will be directly affected by Grain Belt Express Clean Line Energy. This energy line is one of many proposed lines that would be operated by Clean Line Energy, LLC. I am adamantly opposed to this private investment group being able to use Eminent Domain to gain control of Missouri farms for their own financial gain. I would like to explain how this will personally affect me.

My husband and I rent a home in Cameron, MO from my father. Our home is located on 6 acres and it lies directly next to my parent's 270 acre farm. My husband and I recently married in August of 2013 in our back yard. We planned on buying the house and acreage from my father early 2014. We also plan to have children sometime during 2014. One of the proposed lines would run behind my home as well as all through my parent's farm. My brother and sister in law, and their 6 month old child, live down the road. The line also will run through their farm.

Now that these towers might be approved, I am fearful to buy the home from my father. I have never owned a home and have been very excited to own my house and the land. However; now, I that this company has proposed these energy lines, I am afraid of how much the value of the property will decline. If we buy the home and the towers are built, the value will plunge and I'll be stuck with an overvalued mortgage. If I don't buy the home, my father is stuck with an overvalued mortgage. Either way, I and my family members are personally and financially affected.

Beyond the financial aspect of this is my concern of health effects. These lines will carry wattage that is 3 times stronger than the wattage necessary to power Hoover Dam. I have read studies that have linked HVDC energy to cancer, especially childhood leukemia. I am absolutely fearful to raise a child remotely close to this energy.

Because this will have a direct impact on my family, I have researched these types of energy lines, and current lines across the globe. There are a few in California and people living in the area have written articles about how badly these lines affected their quality of life. There are lines in the Netherlands and also across the UK. In the Netherlands, these towers and wind farms were built and then once they were put in operation, they quickly were shut down due to the inefficiency of wind energy. There are abandoned wind farms all across the country as well as these massive unused lines.

I read an article that states, currently in the United States there are around 14,000 abandoned wind turbines. I encourage you to read an article I found. It discusses the ineffectiveness of wind energy and how the intent of the investors is simply to gain the easements and receive government subsidies (http://www.libertynewsonline.com/article 301_31276.php). The company Clean Line Energy has already announced that at any time after the project is approved by the Public Service Commission of Kansas, Missouri, Illinois and Indiana, they have the right to sell all the easements. This includes before the construction begins, and any time during construction. In the UK, a company called National Grid is already building these types of power lines across the UK. There was a hearing with the ICC where it was stated that National Grid has the right to acquire (ultimately OWN) Rock Island Clean Line, any of the other subsidiary projects, or "Clean" Line at any time- before or after completion (one of those lines being the Grain Belt Express).

Clean Line proposed a line through Arkansas and they were not granted public utility status. Here is a link to the ruling: Ihttp://www.apscservices.info/pdf/10/10-041-u 41 1.pdf

We held a public meeting in Cameron and invited citizens around the area to come and receive information. It was alarming how many were not even aware of the project, but even more alarming of how many thought they would receive the clean energy. Our citizens have been misinformed by the information passed around by the local offices of this company. I went to their website, grainbeltexpresscleanline.com, and read every link and every study. It clearly states that only cities near a converter substation will be able to purchase the energy. They state in one link that there is a possibility of a converter station being built in St. Louis. In my opinion, it is highly unlikely that the substation would be built due to the extreme high cost to build the substation after I have researched current transmission lines and the ineffectiveness of wind farm energy. If this company already speaks of selling the easements once gained, I doubt they would invest in a substation that is such a high cost and is merely been state a remote possibility. The only recipients of the energy would then be on the east coast. There have been governors of states on the east coast who have expressed opposition to this project because they want to invest in their own type of renewable energy.

I have talked with many landowners in the area and not a single one said they would take the easement money if they had the chance. Even if easement money is received, the land owner still is required to pay the property tax on the land even though they cannot use the land. It is not right. This whole project is not right. I hope you view our hardwood forests as a beautiful natural resource that we should manage and protect. Lastly, I hope you view Missouri farmers as real people with many years of blood, sweat and tears lovingly invested in our great Missouri
farms. Grain Belt Express Clean Lines view the Missouri landscape as a commodity for their personal financial gain, with no regard for the devastation that will ensue on our farms and in our lives.

As a resident of Missouri and a hopeful future landowner of Missouri, I plead with the PSC to deny "Utility Status" to Grain Belt Express. The drawbacks far outweigh the benefits for our great state. A private investment group from another state should not be able to walk in to Missouri and take our land. It's not right and I hope you have your citizens' best interest in mind when you make your decision.

Dear Commissioner Stoll,
I live in Clinton County Missouri and will be directly affected by Grain Belt Express Clean Line Energy. This energy line is one of many proposed lines that would be operated by Clean Line Energy, LLC. I am adamantly opposed to this private investment group being able to use Eminent Domain to gain control of Missouri farms for their own financial gain. I would like to explain how this will personally affect me.

My husband and I rent a home in Cameron, MO from my father. Our home is located on 6 acres and it lies directly next to my parent's 270 acre farm. My husband and I recently married in August of 2013 in our back yard. We planned on buying the house and acreage from my father early 2014. We also plan to have children sometime during 2014. One of the proposed lines would run behind my home as well as all through my parent's farm. My brother and sister in law, and their 6 month old child, live down the road. The line also will run through their farm.

Now that these towers might be approved, I am fearful to buy the home from my father. I have never owned a home and have been very excited to own my house and the land. However; now, I that this company has proposed these energy lines, I am afraid of how much the value of the property will decline. If we buy the home and the towers are built, the value will plunge and I'll be stuck with an overvalued mortgage. If I don't buy the home, my father is stuck with an overvalued mortgage. Either way, I and my family members are personally and financially affected.

Beyond the financial aspect of this is my concern of health effects. These lines will carry wattage that is 3 times stronger than the wattage necessary to power Hoover Dam. I have read studies that have linked HVDC energy to cancer, especially childhood leukemia. I am absolutely fearful to raise a child remotely close to this energy.

Because this will have a direct impact on my family, I have researched these types of energy lines, and current lines across the globe. There are a few in California and people living in the area have written articles about how badly these lines affected their quality of life. There are lines in the Netherlands and also across the UK. In the Netherlands, these towers and wind farms were built and then once they were put in operation, they quickly were shut down due to the inefficiency of wind energy. There are abandoned wind farms all across the country as well as these massive unused lines.

I read an article that states, currently in the United States there are around 14,000 abandoned wind turbines. I encourage you to read an article I found. It discusses the ineffectiveness of wind energy and how the intent of the investors is simply to gain the easements and receive government subsidies
(http://www.libertynewsonline.com/article 301 31276.php). The company Clean Line Energy has already announced that at any time after the project is approved by the Public Service Commission of Kansas, Missouri, Illinois and Indiana, they have the right to sell all the easements. This includes before the construction begins, and any time during construction. In the UK, a company called National Grid is already building these types of power lines across the UK. There was a hearing with the ICC where it was stated that National Grid has the right to acquire (ultimately OWN) Rock Island Clean Line, any of the other subsidiary projects, or "Clean" Line at any time- before or after completion (one of those lines being the Grain Belt Express).

Clean Line proposed a line through Arkansas and they were not granted public utility status. Here is a link to the ruling: http://www.apscservices.info/pdf/10/10~041-u_41_1.pdf

We held a public meeting in Cameron and invited citizens around the area to come and receive information. It was alarming how many were not even aware of the project, but even more alarming of how many thought they would receive the clean energy. Our citizens have been misinformed by the information passed around by the local offices of this company. I went to their website, grainbeltexpresscleanline.com, and read every link and every study. It clearly states that only cities near a converter substation will be able to purchase the energy. They state in one link that there is a possibility of a converter station being built in St. Louis. In my opinion, it is highly unlikely that the substation would
be built due to the extreme high cost to build the substation after I have researched current transmission lines and the ineffectiveness of wind farm energy. If this company already speaks of selling the easements once gained, I doubt they would invest in a substation that is such a high cost and is merely been state a remote possibility. The only recipients of the energy would then be on the east coast. There have been governors of states on the east coast who have expressed opposition to this project because they want to invest in their own type of renewable energy.

I have talked with many landowners in the area and not a single one said they would take the easement money if they had the chance. Even if easement money is received, the land owner still is required to pay the property tax on the land even though they cannot use the land. It is not right. This whole project is not right. I am 27 years old and can see how horrific this will be if built in our state. My husband and I are trying to establish ourselves and prideful Missouri landowners, but at age 27 we are already seeing this might not be a dream we can achieve in this area of Missouri. My entire family lives in this area, so the idea of moving isn't very appealing. I lived in Columbia, MO for 6 years and then worked and lived in Kansas City. I moved back to Cameron for the quality of life. Now that quality of life is being threatened before I even have the chance to establish myself as a landowner.

I dearly hope that the Missouri Public Service Commission views Missouri farms as the backbone of our state. I hope you view our hardwood forests as a beautiful natural resource that we should manage and protect. Lastly, I hope you view Missouri farmers as real people with many years of blood, sweat and tears lovingly invested in our great Missouri farms. Grain Belt Express Clean Lines view the Missouri landscape as a commodity for their personal financial gain, with no regard for the devastation that will ensue on our farms and in our lives.

As a resident of Missouri and a hopeful future landowner of Missouri, I plead with the PSC to deny "Utility Status" to Grain Belt Express. The drawbacks far outweigh the benefits for our great state. A private investment group from another state should not be able to walk in to Missouri and take our land. It's not right and I hope you have your citizens' best interest in mind when you make your decision.

I just called your office and left a message with your secretary. I would love to spend a few minutes speaking with you in person. Please call me at . Your secretary is awesome!

I very much oppose the Grain Belt Express. My wife and I are both 55 years old. 3 years ago after getting all six kids out of the house, we bought a 40 acre farm, which is beautiful. While I manage human tissue transplants across 3 states, $\square$ is the retirement business.

We have planted hundreds of apple trees. We also are now the third commercial bittersweet farm in the US. Bittersweet is the native orange berried shrub that use to grow in fencerows, and you went and it picked it in the fall with your Grandma. Our business plan is to promote agri-tourism in NW Missouri. Families can come pick apples, kids can make their own apple cider, pick pumpkins, pet the lambs, feed the chickens, etc.

The Grain Belt Express wipes us out, wipes out the orchard. It severely affects same family farms. I will give you a couple of examples. Helga, my fried and neighbor to the west, is 65 years old. She has a small family dairy of 30 cows on 80 acres. The Grain Belt Express wipes out her dairy farm and her retirement income. Ms. Boone, a widower in her late 60"s, raises Prime Kobe beef on her 120 acre farm. Kobe beef is very, very expensive. This is Ms. Boone's retirement income.

The point I am trying to make is the Grain Belt Express wipes out small family farms across the state, folks who work hard, don't ask for handouts from the government, and have built very nice boutique farms that generate very good incomes. I understand from speaking with my friends, who are large landowners, farming hundreds and thousands of acres, primarily in cattle, corn and soybeans, they generally don't oppose the Grain Belt Express. It does not wipe them out, as the lines are miles from their homes, and they view it as an income source.

As a lifelong Missouri boy, we live in the most beautiful state in the nation, and I have traveled on business to all of them. I completely fail to understand why we would want to place a scar on our state with these hideous lines. Generally speaking, most cities across the state require electric lines to be built underground. I would not oppose the Grain Belt Express if it were buried underground along existing utility easements like I-70, 36 highway, or the natural gas pipeline easement already in place. In my humble opinion, this is the correct solution if this company wants to do business in our state.

Speaking of the company, I have done extensive research on this company. My name is Jeff Gatrel and I am a resident of Caldwell Co. Mo. The GBE power line is running through here on two proposed routes. The northern route will run within approximately 300 of my house. This is of great concern to me because my wife stays home with our two young children. They are in the house or on the farm about $90 \%$ of their lives. We also have a cow-calf operation and the route will be running through my bull pens where my breeding bulls spend most of the year. The line will run through our farm for approximately 1 mile. All of our farm is pasture and my Dad owns the biggest part of our acre farm. We feel that this line will ruin our farm for running cows. We are also concerned about the long term effects of the 600,000 volts of DC power that we will be exposed to on a daily basis. We will not live in our house no matter who says it is safe to do so. It just doesn't make any sense.

The southern route which runs just North of Polo will effect my business. My wife and I own a welding shop where we fabricate equipment for the Livestock Industry. It is a thriving business where we employ
full time employees. This proposed route, I believe, will run just north of my property line. I will be within $\square$ feet of the lines anytime I am at my place of business. I simply will have to shut down the location. It is especially troubling because I just built the shop in 2011 and it is not payed for. I will likely receive no monetary compensation since it will not be on my property. I will be subject to the health risks and loss in property value.

I feel this line will not help the county or Northern Missouri in any way that could cover the costs in personal property loss, potential business loss, and health concerns.

About four months ago a sign popped up next to my neighbor's driveway that saying, 'Block GBE'. I had no idea what it was, and promptly forgot about it.

A month ago my mother-in-law asked me if she could put one of these signs next to our driveway. I asked what it was for and she explained what the Grain Belt Express was... and I was horrified! I was amazed that this wasn't something that was on the news or in the paper, or at the very least, blowing up all over Facebook.

I did a little research on the GBE via the company's official site. I discovered that not only are these transmission lines ridiculously huge (200ft) one of the potential lines runs just an acre away from my house, if that. Another potential line (if the previous one fails) runs a quarter mile from my house, which would be interfering with my neighbors property.

The GBE will decrease property values, and force us to move. I can't live that close to 3,500 megawatts going directly past my house. We will just look past the superficial face that hundreds of miles of metal would just be a complete eyesore.

More importantly, farmers will not be able to continue to farm on their land. The GBE cuts through many family farms and if WiFi can cause damage to plants, then I would assume that 3,500 megawatts of power can damage crops. The United States produces $32 \%$ of the world's corn, and while I don't know the percent that Missouri contributes to that, Missouri is already down $7 \%$ in their corn production.

The people in Missouri need to know more about this. It doesn't just affect those who are in the area of the GBE. It affects all of us. If farmers can't farm, people don't get food. Please let me know what I can do to block the GBE.

I am a Missouri landowner and farmer that is being directly affected by Grain Belt Express Clean Line Energy. I am adamantly opposed to this private investment group being able to use Eminent Domain to gain control of Missouri farms for their own financial gain. I would like to explain how this will affect us economically and personally.

My husband and I moved to the farm 25 years ago from the middle of a major city. We own a $\square$ acre organic cattle ranch near Cameron, Mo and have been good stewards of the land. We sell directly to customers and restaurants. We have many customers come to the farm to view both the cattle and farm. Several times a year we have a customer appreciation day. Our customers have expressed how they love getting food from a local farm, and love coming and spending time on the farm. We have planned on expanding more in to Agritourism. It is a very sustainable form of farming. We know our customers, they know the source of their food and the dollars stay local. This will all change for us if Grain Belt Express is granted "Utility Status" by the Missouri Public Service Commission. I am writing to you as a concerned land owner in Caldwell County Missouri. My husband and I purchased our home and $\square$ acres in Nov of 2012. We were looking for an area close enough to employment, yet still be able to live in the country to raise our 3 boys and grow our own food. I assume you are not familiar with the type of people who live in Caldwell County. I have found that most people who choose to reside in our county are all trying to be somewhat self sustaining in how we live. The Grain Belt Express project would destroy many small family farms through our county. The middle route proposed to go through would be on the northern border of our property. (Our mostly wooded property I would like to add. It is hard to find wooded acreage in this part of the state. My husband and I looked at buying a home in Kansas but couldn't stand the thought of having maybe one or two trees.) This project would clear cut a very large percentage of our trees. This alone would devalue our property. Our home is solely heated with wood heat and if the trees are removed and can not be allowed to grow back this too would cause our family distress. From the research that I have seen on these power lines the health risks from living so close to them is not something that we are willing to take a chance on. We pride ourselves in trying to live off what nature can provide with growing our own fruits and vegetables and raising chickens. We have plans to be able to grow a high percentage of our own food and this project could completely destroy that. I would not be able to continue in good conscience to raise my children so close to the power lines, so we are looking at having to relocate if this project happens. Since we just purchased our home a little over a year ago and and the fact that re-selling it would most likely be impossible for near what we owe on it, we would have the risk of having to face a foreclosure just to keep our children safe.

I know that energy has to have advances, and have improvements, but I do not believe that we should have to sacrifice our safety. I have seen information about these lines being buried and that the risks are greatly reduced to the people around them. I do not understand why this company isn't trying to put these lines near a right away that already exists, like interstate 70 or 36 Hwy . Why do they need to cut through farm land? I ask that you deny Clean Line and the Grain Belt Express Project. Not only because of this project, but because of what approving this could mean for the future of eminent domain being used in Missouri. Mr. Stoll,
I'm writing to you in opposition of the Grain Belt Express. My family owns property in northeast Kansas that will be impacted by the project. I am reaching out to you in Missouri because of the lack of response and a perceived lack of consideration that Kansas officials offered property owners like us.

In my family's specific case, the edge of the easement line would be approximately 200 yards from where my greatgrandfather homesteaded.
Although the original buildings have since been torn down, it's been a family desire to build a home on that property. In fact, over the years, our family has been approached by others with interest to build on the piece of property because of the scenic views, but it's value to us and the potential for our family is too important for us to consider selling. This project would threaten, and in our mind prohibit, the realization of our plans to build on the property. Who wants to look at the ugly towers every day and be exposed to the factors that have been linked to health issues? Would you threaten the lives of your children or grandchildren? Because the easement doesn't actually touch our property, there is no offered compensation from Clean Line for the loss of value of our land or the loss of potential use.
We would lose, while a private company with the power of eminent domain would gain. Clean Line made no effort to address our desire to adjust the line so our dreams to build in the prime location would be spared.
Furthermore, the land work that will be done is all uphill from our ground, any erosion that results from removing trees and clearing cover will directly impact our land. None of these potential problems were ever addressed by Clean Line or the KCC.

Overall, public comment in Kansas was more than $97 \%$ opposed to the project.
The KCC responded by dismissing the opposition as simply "numbers". How disrespectful to the people of Kansas. Most of the concerns property owners had and have were never addressed by the KCC or Clean Line. The lack of independent study on health and environment and lack of independent expert testimony in the KCC docket documents and at the hearing left property owners feeling like their actions were nothing but a charade.

Property owners see no benefit to the project except for a very few number of wind energy developers. These few people stand to become even more wealthy, yet offer negatively impacted property owners less than fair compensation for easement property value, no ongoing payments to compensate for the loss future property value loss, no compensation for adjacent property value loss, no royalties for the billions of dollars of electricity flowing across the property. All of these compensation options are real and fair, other wind industry projects and communication tower projects recognize neighboring property losses due to the aesthetic and noise impact, they over good neighbor payments to offset the losses (see pages 18-20 of the attached document). Clean Line Energy fails to recognize these losses and compensation options, despite one of their representatives being listed as a reviewer of the attached document.

Knowing that Clean Line Energy has never built or maintained a single transmission line of any size, and no transmission line of this size has ever been built by any company ever, is significant. National Grid's (UK) option to purchase the project pre-construction or anytime thereafter should be a clear indication that Clean Line only serves to gain access to private property, and may have no intention to actually build or maintain the project. Property owners deserve to know who is really getting access and will be responsible for respecting our most precious resource.

If land values decrease, which the obviously will as shown by the lack of interest in for sale property that is threatened by the line, how do counties make up for the loss in property tax revenue? How many other costs will be incurred by the local economies? None of these things have been studied or addressed. This is just the tip of the iceberg when it comes to the lack of attention and study that should be required for a project such as this. The job number estimates Clean Line has given needs to be vetted, they seem to be super inflated, how much maintenance does a transmission line really need?

When you consider that Kansas only uses 2800 mW of renewable energy for itself, how can one believe that exporting 3500 mW over 750 miles is really necessary? Kansas Westar just announced they will be importing 700 mW of wind energy from Oklahoma. Guess Oklahoma wind is cheaper than the wind in our own state. One should also remember that there is no way to control, restrict or monitor the amount of non-renewable energy that this line would carry. The coal plants in Western Kansas would be very close to the beginning point of this line, making one wonder if the true intent is to export coal energy, and the wind energy propaganda is only a selling point to get the line built.

Thank you for considering all of these points. There are many more that I could bring up, like Clean Line's failure to notify property owners. It is a fact that certified letters they mailed were returned to sender and Clean Line made no effort to find out why. It was because they sent letters to the land parcel address, not the residence of the owner. I don't know how many instances of this happened, because the KCC and Clean Line wouldn't reveal that information.

I ask that you really consider Clean Line's integrity, or lack thereof, in regard to this project. Thanks again for the opportunity to share my experience and knowledge about the project with you.

Dear Commissioner Stoll,
I am reaching out to you to voice my concerns regarding the opposition to the private for profit corporation Grain Belt Express Clean Line, and request that Missouri Public Service Commission DENY approval of their application to become a public utility, allowing them the authority of eminent domain. The proposed high voltage direct current lines have no proven benefit to the residents of the State of Missouri in either transmitting or receiving energy for our state. If constructed, these towers and high voltage transmission lines would significantly decrease property values on potentially thousands of properties; cause a loss of productive farmland; scar the landscape forever; negatively impact hunting, recreation and agritourism; and could cause serious health effects, according to some studies. As a Nurse, I am not only concerned with the health and wellness of my family but also of my community.

This High Voltage Direct Current transmission line, the Grain Belt Express, would carry 3500 megawatts, 640,000 kilovolts. That is 3 times the power generated by the Hoover Dam and it is proposed to be built utilizing $120^{\prime}-200^{\prime}$ high towers on our farm and on the properties of many other Missourians. Missouri would benefit only slim gains from this proposal and it would bring hazards and health risks to the citizens, livestock, farmland and wildlife. Agriculture is important to Missouri and so are the lives and land of the people who call it home.

Governors of 11 eastern states that this Grain Belt Express would provide energy to signed letters to Senate Majority and Minority leaders stating they do not want this proposed Midwest energy because it undermines their abilities to develop superior wind resources they have offshore less expensively to ratepayers.

Take pride in Missouri and the advancements that utilize clean renewable energy technologies across the state to protect, preserve and enhance Missouri's natural energy resources and keep profits in our state. The proposed project has no relationship with local electric companies and many landowners have their property owner rights at risk. Dear Commissioner Stoll,
I am reaching out to you to voice my concerns regarding the opposition to the private for profit corporation Grain Belt Express Clean Line, and request that Missouri Public Service Commission DENY approval of their application to become a public utility, allowing them the authority of eminent domain. The proposed high voltage direct current lines have no proven benefit to the residents of the State of Missouri in either transmitting or receiving energy for our state. If constructed, these towers and high voltage transmission lines would significantly decrease property values on potentially thousands of properties; cause a loss of productive farmland; scar the landscape forever; negatively impact hunting, recreation and agritourism; and could cause serious health effects, according to some studies. As a Nurse, I am not only concerned with the health and wellness of my family but also of my community.

This High Voltage Direct Current transmission line, the Grain Belt Express, would carry 3500 megawatts, 640,000 kilovolts. That is 3 times the power generated by the Hoover Dam and it is proposed to be built utilizing $120^{\prime}-200^{\prime}$ high towers on our farm and on the properties of many other Missourians. Missouri would benefit only slim gains from this proposal and it would bring hazards and health risks to the citizens, livestock, farmland and wildlife. Agriculture is important to Missouri and so are the lives and land of the people who call it home.

Governors of 11 eastern states that this Grain Belt Express would provide energy to signed letters to Senate Majority and Minority leaders stating they do not want this proposed Midwest energy because it undermines their abilities to develop superior wind resources they have offshore less expensively to ratepayers. Take pride in Missouri and the advancements that utilize clean renewable energy technologies across the state to protect, preserve and enhance Missouri's natural energy resources and keep profits in our state. The proposed project has no relationship with local electric companies and many landowners have their property owner rights at risk. Some Missourians will be forced to sell easements or face condemnation through Eminent Domain. Property value would decrease up to $50 \%$ causing losses that far outweigh the compensation.

Please take these concerns into consideration and deny approval of their application to become a public utility. The mission statement of the P.S.C. is similar to what it was when my Grandfather, Frank May, held position of Commissioner 50 years ago. It now states to "ensure that Missourians receive safe and reliable utility services" and "provide an efficient regulatory process that is responsive to all parties, and perform our duties ethically and professionally." Please uphold the standards of your mission by denying their application to become a public utility. Thank you for your time and understanding in this matter.

Dear Mr. Steve Stoll,

On the morning of November 26, 2013, at 9:00 a.m. Clean Line Energy - Grain Belt Express - the 700+ mile long wind energy transmission line - held a project update presentation during the PSC agenda meeting. During that presentation one of the Mo PSC Commissioners posed a question to the Clean Line rep as to whether they had received any organized opposition to the Grain Belt project. Clean Line's response was it was receiving "tremendous support overall although they have run into some opposition in Caldwell County".

Given this response by Clean Line, and as a landowner along one of the proposed Grain Belt transmission routes in Caldwell County, Missouri, I feel compelled to tell you that there is a growing movement across the entire Midwest against Clean Line Energy and their projects. Clean Line has a practice of sending reps in early across their target states, making unrealistic promises to county commissioners and county reps early on in the process before landowners are aware. Clean Line would like you to believe they have "tremendous support overall", but most landowners along the proposed routes either do not know that Grain Belt exists, or they have contacted their commissioners with their concerns and were told it is a done deal, so now they feel hopeless to intervene. I still meet landowners, even in Caldwell County, that are still not aware of the Grain Belt project proposed to cross their property. Every landowner I do know is NOT for this line, and resents this private investment company from Texas seeking the power of eminent domain for their and their international investor's private gain.

The Kansas Corporation Commission ( KCC ) granted public utility status to Grain Belt before the landowners were notified. Landowners, Marshall County, Nemaha-Marshall Electric Cooperative, Mai Oil and others intervened at the KCC against Grain Belt and are appalled at the treatment they received. They were given little time to protest effectively. It is interesting that Mr . Sievers of the KCC references the 2600 public comments, but in his Concurring Statement he only cites the 260 letters of support for Clean Line. I guess those other 2340 respondents that opposed Grain Belt did not matter to the KCC, as they seem "Hell bent" on completely sanitizing and cleansing the docket of any opposing testimony. Please assure us that the MO PSC is not corrupt, as we have found the KCC to be. Then we will rest easier knowing that landowners will receive fair treatment in this case when Grain Belt files for public utility status in the spring of 2014.

Another Clean Line Energy project, the Rock Island Clean Line (RICL) through lowa and Illinois, is receiving tremendous opposition. The Illinois Dept of Agriculture, the IL Farm Bureau, and Com Ed have all come out against Clean Line. I have included a quick fact sheet overview from the Illinois Commerce Commission (ICC) Testimony Highlights: Docket 12-0560 that raises major concerns about the necessity and feasibility of RICL. View this website here for more info: waw blockricl.com. Since Clean Line uses the same business model for its projects across the Mid-West, these concerns would also apply to Grain Belt. Recently, on November 26, 2013, the lowa Utilities Board (IUB) denied RICL's petition for bifurcation of the franchise process. This decision was made based on the motion of resistance filed by the lawyers fighting on behalf of the Preservation of Rural lowa Alliance, and all landowners, tenants, businesses, families, community members, and the Consumer Advocate's Resistance. This
sends a clear message to Clean Line that Iowan voices will be heard and they will not receive the same treatment that Kansans received. You can read ORDER DENYING MOTION TO BIFURCATE on the IUB website link here:

I have also included a compilation of information gathered by concerned landowners and affected parties to show the truth behind Clean Line Energy Partners LLC and some of the tactics they are using that are contrary to the image that the company represents to the public. Its purpose is to inform and examine "Grain Belt Express: The Other Side of the Story". It is my understanding that since Clean Line has not filed its case yet, sending this information should not violate any Mo PSC rules on improper communications.

I would also like to draw to your attention that as of November 22,2013, three separate courts have held the wind energy industry responsible for damages. See enclosed article. There is a precedence being set that the operation of wind turbines non-stop put residents living near them at risk of "irreparable physical and psychological harm." Neighbors had complained of negative health impacts since the turbines were built. Also, in the first-ever criminal prosecution of a wind company for illegal bird kills under the Migratory Treat Act, Duke Energy Renewables, Inc. pled guilty and was ordered to pay one million dollars. Duke's wind projects in Wyoming slaughtered 14 golden eagles and 149 other protected birds. In France, meanwhile, a judge earlier this month ordered 10 wind turbines taken down for destroying a community's rural character with ""unsightliness of white and red flashing lights." in France, 50 percent of wind projects are now in court. Those of us on the transmission end of the Clean Line -Grain Belt project have many similar concerns about the health, safety, and the decreased property value impact of living too near HVDC power lines. My home is only 300 feet from a proposed 20 story tall tower, and my neighbor is even closer.

Thank you for your time and earnest investigation into Clean Line's claims. As concerned citizens we look to the Missouri PSC to protect our right to private property and to give us a voice on how that property is used and how these hideous power lines will affect our rural quality of life. It is certainly not in the best interest of Missouri to allow this private investment company to facilitate the installation of unneeded, unwarranted, and inefficient transmission lines and wish to take easements for perpetuity using the power of eminent domain.

I understand that Clean Line Energy, LLC from Houston, TX has been in contact with the Missouri Public Service Commission in regards to the portion of the proposed Grain Belt Express Clean Line that runs through Missouri. Please know that the people we are contacting are along Grain Belt's proposed routes (there are several routes in each county), by and large, are not even aware of the project. Many people on a proposed route have not been contacted by Clean Line and were not aware, nor attended the open houses for their area. Needless to say, they are shocked, incensed and very motivated to organize opposition with us, Caldwell County and throughout the state. We are holding our own informational meetings across the state to warn people what may be coming their way and show the "other side of Clean Line".

I do not know if Public Service Commissions stay aware of what other states are doing if the same project crosses state lines or is very similar, but surely you know that Illinois has denied Rock Island Clean Line public utility status thus far for a laundry list of reasons. Kansas landowners are fighting the public utility status recently granted, Arkansas has denied Plains and Eastern Clean Line public utility status, as well. Just yesterday, the Iowa Utilities Board DENIED RICL's (Rock Island Clean Line) petition for bifurcation of the franchise process. This decision was made based on the motion of resistance filed by the Alliance Lawyers on behalf of The Alliance and all landowners, tenants, businesses, families and community members and the Consumer Advocate's Resistance. This is an important step in the process of stopping RICL in Iowa.

Please know that we are educated and professional in our efforts. We will be sending you factual information that we have gathered and compiled. We look forward to the opportunity to meet personally with the Missouri Public Service Commission when Clean Line applies to become a public utility in Missouri and public hearings are held.
