Kansas City Power & Light Company ("Company" or "KCP&L") Hoot Doktab County Harrison Grandy Harrison Hootsway Harrison Grandy Service Territory has filed a rate increase request with the Missouri Public Service Commission ("PSC"). The proposed increase is approximately 10.77 percent. For the average residential customer the proposed increase is approximately \$11.92 per

KCP&L believes the proposed rate increase is needed to recover money spent upgrading the company's infrastructure, adding regional transmission lines, and complying with environmental and cybersecurity mandates.

month. KCP&L's service territory is represented by the shaded

area in the map.

KCP&L is asking the PSC to allow it to continue to reflect changes in its fuel and purchased power costs in customer Fuel Adjustment Clause ("FAC") charges. The FAC's base cost of energy gets reset in each rate case proceeding. Of the 10.77 percent proposed increase, the reset of the FAC accounts for approximately 3.3 percent of the proposed increase. With KCP&L's FAC request, the difference between the fuel and purchased power costs KCP&L actually incurs and a base cost will be billed or credited to each customer based on that customer's monthly energy usage. KCP&L is requesting to continue to adjust the rate used to determine the FAC charges on customers' bills two times per year, in October and April.
