MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority in Missouri of Tele-Reconnect, Inc. ("the Company) and states as follows:

1. On October 17, 2003, the Commission granted a certificate of interexchange service authority to the Company in Case No. CA-2004-0088.

2. On January 22, 2010, the Company filed Articles of Dissolution with the Missouri Secretary of State, seeking to dissolve the Company (a Missouri corporation) effective February 1, 2010. The Staff submits a copy of the Request for Termination, a Certificate of Tax Clearance, and a Certificate of Termination, collectively labeled Attachment A.

3. According to §351.476.1, [a] dissolved corporation continues its corporate existence but may not carry on any business except that appropriate to wind up and liquidate its business and affairs[.] Because the Company can no longer lawfully provide telecommunications services in Missouri, Staff recommends the Commission cancel the certificate.

4. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the tariff(s) and certificate of service authority of Tele-Reconnect, Inc. to provide basic local telecommunications service in Missouri.


