**MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the certificate of service authority of Pay Phone Company, Inc., ("PPC" or "Company") and respectfully states as follows:

1. On November 7, 1990, the Commission granted PPC a certificate of service authority to provide private pay telephone service in the state of Missouri in Case No. TA-91-49.

2. Recent attempts to contact PPC at the on-file e-mail address returns correspondence as undeliverable, and the Company's telephone number is no longer in service.

3. PPC is also delinquent in the payment of its Fiscal Year 2012 assessment.

4. On July 26, 1990, the Missouri Secretary of State's Office dissolved the Company's authority to do business in the state of Missouri. See Attachment A.

5. Pursuant to Section 351.602.3, RSMo (2000), "the authority of a foreign corporation to transact business in this state ceases on the date shown on the certificate revoking its certificate of authority."

6. Because of Staff's good faith belief that PPC is no longer in business in Missouri and by statute can no longer lawfully provide telecommunications services in

the state, Staff recommends that the Commission cancel the Company's certificate of service authority.

7. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo (Supp. 2010), which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

8. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W. 2d 494 (Mo. App. W.D. 1989).

**WHEREFORE**, the Staff recommends that the Commission cancel the certificate of service authority of Pay Phone Company, Inc., to provide private pay telephone service in the State of Missouri.
