MOTION TO CANCEL PROCEDURAL SCHEDULE AND SET A NEW PREHEARING CONFERENCE

COME NOW NuVox Communications of Missouri, Inc. ("NuVox") and XO Missouri, Inc., pursuant to 4 CSR 240-2.090(4) and for their Motion to Cancel Procedural Schedule and Set a New Prehearing Conference, with consent of all parties¹, state to the Commission as follows:

NuVox has herein filed a complaint against Southwestern Bell Telephone,
L.P. d/b/a SBC Missouri ("SBC"). On September 9, 2003 the Commission consolidated
NuVox's complaint proceeding with cases involving similar complaints filed by XO

Missouri, Inc., Birch Telecom of Missouri, Inc., AT&T Communications of the Southwest, Inc., TCG Kansas City, Inc., and TCG St. Louis, Inc.

- 2. Since the Commission issued its order consolidating these matters, NuVox and SBC have been able to negotiate a settlement of the NuVox complaint. Upon approval of the interconnection agreement amendment filed to implement that settlement, now pending before the Commission under Case No. XK-2004-0221, NuVox will dismiss its complaint. However, the Commission has until February 10, 2004 under 47 USC 252(e) to resolve that interconnection amendment proceeding.
- 3. Under the procedural schedule now in effect in this consolidated matter, NuVox and SBC would have to continue to devote substantial resources regarding the NuVox complaint notwithstanding their settlement agreement. Neither party should have to waste its resources in this manner.
- 4. Furthermore, the parties notified the Commission on or about November 21, 2003 that they had released the hearing dates set in this proceeding to facilitate the proceedings in Case No. TO-2004-0207. All the parties are currently devoting substantial resources to that proceeding.
- 5. With consent of all parties, NuVox and XO Missouri move the Commission to cancel the procedural schedule in this consolidated case and set a new prehearing conference. Such action will allow NuVox to conclude its settlement with SBC and allow XO and the other parties an opportunity to develop and propose a new hearing date and a new schedule coordinated with that hearing date.
