**OFFICE OF THE PUBLIC COUNSEL'S
PETITIONS ON BEHALF OF CUSTOMERS IN THE
ROCKAWAY BEACH EXCHANGE FOR AN EXPANDED
TOLL-FREE CALLING SCOPE TO BRANSON**

COMES NOW the Office of the Public Counsel (Public Counsel) and files petitions signed by the majority of the telephone customers of CenturyTel's Rockaway Beach exchange (NXX 561-0000) requesting that the customers of that exchange have toll-free calling into Branson because of the close community of interest of the customers to the Branson exchange. Prior to the termination of Community Optional Service in Case No. TW-98-333, this exchange was the petitioning exchange for COS service to the Branson target exchange. The customers believe that a suitable replacement for that service has not been provided and now seek relief from CenturyTel, the new operator of the exchanges at issue, and from the Public Service Commission of Missouri.

Public Counsel believes that it is in the public interest for the concerns of these telephone customers to be brought before the Commission and for the customers of that community to be able to petition the telecommunications regulatory authority for relief and be heard. For that reason, Public Counsel has agreed to present the petitions to the Commission and to request a public hearing in the exchange to provide the customers with a forum for their concerns. A public hearing would afford them an opportunity to properly communicate their concerns to the company and to the Commission in the

context of a case so that the customers and government agencies in the area have notice of any meeting or hearing concerning expanded calling and public comments can be suitably recorded. Public Counsel makes this filing to accommodate these consumers and to present their views to the Missouri Public Service Commission.

Public Counsel suggests that these petitions, along with pending requests in TO-2001-391 to expand or modify MCA service for Lexington, Wright City, Greenwood, and Ozark, are not just a reaction to the end of Community Optional Service, but evidence the lack of suitable calling plans that give the customers in those areas reasonable and affordable local calling within their communities of interest. The increasing number of customer complaints about limited local calling areas in rural exchanges and the termination of Local Plus are symptoms of the continuing statewide problem. For this reason, Public Counsel asks the Commission to consider the broader implications of this request when determining whether to pursue an investigation into the feasibility and the public interest of granting the petitions.


The rural areas are home to a significant portion of Missouri's vital tourism industry. This is true for the Rockaway Beach community and its long-standing community of interest with Branson as evidenced by the prior COS route.

For these reasons, Public Counsel asks the Commission to (1) accept these customer petitions, (2) open a case and give notice to the company, local governmental agencies, the industry, customers and the public in general of this request, (3) hold public hearings and seek public comments and (4) consider whether the requested expanded calling scope is feasible and whether it is in the public interest and can be provided at just, reasonable, and affordable rates.

New area telephone service began Aug. 31

The Louisiana based company CenturyTel took over operations of telephone service in the area on Aug. 31.

At a press conference held at Chateau on the Lake, CenturyTel officials said they expect to complete the purchase of Verizon's 98 local telephone exchanges in Missouri on Saturday. Around 354,000 local telephone lines and 520 Verizon employees in the state will transfer to CenturyTel.

Region Vice President of Missouri Operations Ken Matzdorff said 112 Verizon employees will have positions with CenturyTel. "The employees will ensure a smooth transition," he said. "It will also give us local knowledge and expertise."

The regional headquarters will be in Wentzville, Mo., and the regional operations center will be in Columbia, Mo. Chairman and CEO Glen Post said Branson will be southern Missouri's headquarters. "We are focused on providing one stop shopping, convenience and value for customers," Post said. "Verizon was focused on the larger cities, but we are focusing on smaller cities and rural areas. We want to become involved in these communities."

A general manager will be

brought into the Branson area. The announcement of the local general manager will come at the end of the week.

New services to be offered in the Branson area will be broadband, DSL (Digital Subscriber Line) and voice mail.

Matzdorff said the company will be looking at how long distance works in the area. A call to Forsyth from Branson is a long distance call. Matzdorff said the company would look at how to make that a local call instead of long distance.

The purchase of Verizon is part of the largest acquisition in CenturyTel's history. The company paid Verizon \$2.16 billion in cash for telephone lines in Alabama and Missouri in October 2001. With the completion of the acquisition, CenturyTel will serve more than 485,000 access lines in the state.

Missouri customers should see no changes in area codes, telephone numbers or local calling as a result of the sale. All local telephone customer accounts will automatically transfer to CenturyTel. Customers will receive CenturyTel bills beginning in early September.

CenturyTel is the eighth largest local exchange telephone company, based on access lines, in the United States.
