NOTICE OF CHANGE APPLICATION

COMES NOW Cable One, Inc. d/b/a Sparklight ("Cable One") pursuant to § 67.2679 RSMo and for its application to expand video service to additional political subdivisions and to provide notice of changes to the Missouri Public Service Commission ("Commission") states as follows:

1. Cable One is a publicly traded Delaware corporation with headquarters located at 210 E. Earll Drive, Phoenix, Arizona 85012. Cable One and its subsidiaries provide video, Internet access, broadband, and voice services in 21 states, including Missouri. In Missouri, Cable One holds authority to provide video service (ID 3835) and is registered as an interconnected Voice over Internet Protocol ("IVoIP") service provider (ID 6833).

2. Cable One's subsidiary, Telecommunications Management, LLC d/b/a NewWave Communications ("TM"), also holds authority to provide video service (ID 5138) and is registered as an IVoIP service provider (ID 7047) in Missouri.¹

3. As part of an internal corporate reorganization, TM was merged with and into Cable One effective December 31, 2020 (the "Reorganization"). Cable One

remains as the surviving entity, and TM has ceased to exist. All of TM's rights and obligations were assumed by Cable One by operation of law. In conjunction with the internal corporate reorganization, all customers served by TM in Missouri are now served by Cable One under the d/b/a name of Sparklight effective January 1, 2021. All former TM customers received notice that their service will be provided by Cable One under the Sparklight brand name.

4. Pursuant to the Reorganization, Cable One will now provide video service in the following political subdivisions, which previously were served by TM pursuant to its Video Service Authorization:
