Zone Telecom, Inc. was granted authorization as a reseller of intrastate telecommunications in Missouri on December 1, 2000 (see authorization granted in Case No. TA-2001-299). Pursuant to Zone's notification letter filed with the Commission on June 29, 2011, Zone Telecom, Inc., a Delaware corporation, was converted into Zone Telecom, LLC, a Delaware limited liability company on March 25, 2011 (see File No. XN-2011-0416). Zone Telecom, LLC registered as an Interconnected Voice Over Internet Protocol Provider which was effective November 5, 2012 (see File No. DA-2013-0189). Please be advised that Zone Telecom, LLC ("Zone") has changed its name to ANPI Business, LLC ("ANPI Business").

ANPI Business respectfully requests that the Missouri Public Service Commission ("Commission") change the name of the Certificate of Authority currently held by Zone Telecom, LLC (File No. XN-2011-0416) and the VoIP Authority (DA-2013-0189) granted on November 5, 2012, to ANPI Business, LLC.
