NOTICE REGARDING CLECS THAT HAVE NOT SELECTED AN ICA

SBC Missouri¹ respectfully wishes to advise the Missouri Public Service Commission ("Commission") that pursuant to the Memorandums of Understanding ("MOUs") executed by the parties listed on Attachment 1 and previously filed with the Commission in this case,² SBC Missouri is providing service to them under the SBC Missouri/Sprint Successor ICA, approved by the Commission in Case No. TK-2006-0044.

As set out in the MOUs, each CLEC agreed to select one of the successor M2A agreements approved by the Commission as a result of the Arbitration in this case no later than 10 business days after the issuance of the Commission's decision approving the first successor agreement (the "MFN date"). If the CLEC did not identify an agreement into which it would MFN by the MFN date, the parties agreed that the CLEC will be deemed to have selected the first approved successor agreement.

The Sprint Successor ICA was the first Successor ICA resulting from the Arbitration in this case that was approved by the Commission. SBC Missouri notified all carriers with whom it executed a MOU that the Sprint Successor ICA was the first successor ICA approved by the

Commission. The letter also reminded them that unless they affirmatively chose another arbitrated agreement by executing a Short Form Agreement with SBC Missouri to MFN into that agreement, they will be deemed under the MOU to have selected the Sprint Successor ICA. SBC Missouri has not received anything from the carriers listed on Attachment 1.³ Accordingly, SBC Missouri is providing service to these carriers under the Sprint Successor ICA.

Although these carriers will now be taking service under the Sprint Successor ICA, they may (as provided in the MOU) subsequently submit a request to SBC Missouri to adopt an alternate successor agreement pursuant to Section 252(i) of the Act, which SBC Missouri will handle via the standard MFN process.
