NOTICE OF INTENDED CASE FILINGS

COMES NOW Liberty Utilities (Missouri Water) LLC d/b/a Liberty and, pursuant to Commission Rule 20 CSR 4240-4.017, submits this Notice of Intended Case Filing with regard to its upcoming general rate case filings. In this regard, Liberty respectfully states as follows to the Missouri Public Service Commission (the "Commission"):

1. Liberty is a Missouri limited liability company with its principal office located at 602 Joplin Street, Joplin, Missouri, 64801, and provides water and wastewater services to customers in its Missouri service areas, as certificated by the Commission. Liberty is a "water corporation," a "sewer corporation," and a "public utility," as those terms are defined by RSMo. §386.020 and, therefore, is subject to the general regulatory jurisdiction of the Commission as provided by law.

2. Liberty intends to file tariffs to initiate general rate case proceedings for its water and wastewater operations. Issues likely to be before the Commission in the upcoming rate cases include those concerning revenue requirement, class cost allocation, rate design, tariff terms, and other matters commonly associated with a general rate case.

3. With regard to Rule 4.017(1) and the requirement that a 60-day filing notice include "a summary of all communication regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to filing the notice," the Company verifies that there have been no ex parte communications regarding

substantive issues likely to be in the intended case between Liberty and the office of the Commission within the 90 days prior to the filing of this Notice.

WHEREFORE, Liberty submits to the Commission this Notice of Intended Case Filing and requests such relief as is just and proper under the circumstances.
