1. To the best of its information and belief, the Aqua Missouri Taos facilities that are the subject of this proceeding are located in three political subdivisions that extend into counties other than Cole County, to-wit, Callaway, Miller and Osage counties;

- a. The Jefferson City School District is located in both Cole and Callaway counties.
- b. The Eugene School District is located in Cole and Miller counties.
- c. The Osage Fire Protection District is located in both Cole and Osage counties.


2. The Taos property of Aqua Missouri is otherwise located in political subdivisions that are, in their entirety, within Cole County, Missouri.


