NOTICE OF CHANGE IN VEGETATION MANAGEMENT STANDARDS, GUIDELINES AND PROCEDURES

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) and states to the Missouri Public Service Commission (Commission) as follows:

- 1. On July 1, 2008, the Company filed its Vegetation Management Standards, Guidelines and Procedures. This information can be found in Case No. EO-2009-0012 and is titled *Vegetation Management Program and Practices*.
- 2. 4 CSR 240-23.030(4)(C) requires the Company to file a copy of any change to this document no later than 30 days prior to the implementation of that change.
- 3. The Company is changing one portion of its filed *Vegetation Management Program and Practices*. Specifically, on page eight, section 7, there is a change to the second paragraph. The second sentence will now read, "At a minimum, contractor management will submit one formal written audit per crew, per month (1-2 days of work)." This sentence formerly stated it would require 2-4 days of work.
- 4. This change is being made to more effectively allocate contractor management time spent with crews and will take effect thirty days from today.
- 5. Pursuant to the Commission regulation set forth above, Ameren Missouri submits this change to its *Vegetation Management Program and Practices*.
