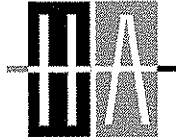


1. The Company has main offices in Missouri located at 1533 South Enterprise Avenue, Springfield, Missouri.




