NOTICE OF CHANGE APPLICATION

COMES NOW, Southwestern Bell Telephone Company, d/b/a AT&T Missouri (AT&T Missouri) pursuant to Section 67.2679.6 RSMo, and for its Notice of Change Application seeking to expand video service to additional areas, state of follows:

1. AT&T Missouri's principle Missouri office is 1010 Pine, Suite 1900, St. Louis, Missouri 63101.
2. AT&T Missouri seeks to clarify its current video franchise to expressly include the following political subdivision:

3. A recent internal review of AT&T Missouri's video franchise records disclosed that AT&T Missouri's franchise did not expressly identify the City of Bellerive, but that AT&T Missouri began serving a small number of residents there.
4. AT&T Missouri records further reflect that it has been paying franchise fees to the City of Bellerive from the date it connected its first customer there, in accordance with franchise obligations.
5. Attached is an affidavit signed by an officer of AT&T Missouri affirming this request.

WHEREFORE, AT&T Missouri requests that the Commission issue an order granting AT&T Missouri video service authorization for the City of Bellerive.
