MISSOURI JOINT MUNICIPAL ELECTRIC UTILITY COMMISSION'S STATEMENT OF POSITIONS

COMES NOW the Missouri Joint Municipal Electric Utility Commission ("MJMEUC"), by and through counsel, Doug Healy of Healy & Healy, Attorneys at Law, LLC, and respectfully states to the Missouri Public Service Commission (the "Commission") as follows:

1. On March 15, 2010, Kansas City Power & Light Company ("KCPL") submitted to the

Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided by KCPL in its Missouri service area.

2. Also on March 15, 2010, KCP&L Greater Missouri Operations Company ("GMO")

submitted to the Commission proposed tariff sheets intended to implement a general rate

increase for electrical service provided by GMO in its Missouri service area.

3. In each case, the Commission issued an Order Approving Nonunanimous Stipulation and Agreement, Setting Procedural Schedule, and Clarifying Order Regarding Construction and Prudence Audit, dated August 18, 2010, directing the parties, in part, to file a Statement of Positions in each case on January 12, 2011. 4. MJMEUC has not filed testimony in either case. MJMEUC was a party to prior Commission cases involving KCPL and its regulatory plan, and MJMEUC is participating in these proceedings due to its involvement with the Iatan 2 plant and common facilities which serve both Iatan 1 and Iatan 2. MJMEUC has a twelve percent (12%) ownership interest in Iatan 2 (as well as a six percent (6%) ownership interest in Iatan common facilities). KCPL is responsible for the operations at said plants, and KCPL managed the construction of Iatan 2.

5. Due to the unique nature of MJMEUC's interest in these cases and MJMEUC's level of involvement in these cases, at this time, MJMEUC takes no position on the issues set forth in the issue list filed herein. MJMEUC reserves its right, as a party to these proceedings, to assert its positions on various issues when evidence is presented to the Commission, to file posthearing briefs, to file true-up testimony, and to otherwise fully participate in the evidentiary hearings to be held herein.
