

EMBARQ MISSOURI, INC.'S NOTICE OF DISMISSAL

EMBARQ Missouri, Inc. (“Embarq”) respectfully submits this notice of dismissal pursuant to 4 CSR 240-2.116(1) and states as follows:

On January 10, 2008, Embarq initiated this proceeding by filing an Application to Declassify Certain Portions of Local Exchange Carrier’s Annual Reports. On January 28, 2008, Big River Telephone Company, Socket Telecom, and XO Communications filed an application to intervene. On January 30, 2008, Charter Fiberlink filed its application to intervene. No prepared testimony has been filed nor oral argument offered in this case. Accordingly, Embarq may withdraw its Application as a matter of right, and may do so without prejudice to refileing its Application. By this notice Embarq’s Application is withdrawn, and Embarq reserves the right to refile the same, or similar, Application.
