Dear Honorable Chairman and Commissioners:

With the best interest of my constituents in mind, I'm writing in opposition to a case before the Missouri Public Service Commission submitted by Noranda Aluminum that requests a 25 percent reduction in its electric rates from Ameren Missouri.

This rate request would shift roughly a half of a billion dollars in costs onto Ameren customers over the next 10 years. All of my constituents and the businesses in my district rely on Ameren Missouri to power their homes and establishments, making it impossible to avoid this rate shift. However, due to an expedited timelines that prevent public hearings, none of them are able to properly express their concerns.

Noranda currently enjoys its own exclusive rate class with the lowest rate of any Ameren consumer, which is about 60 percent less than what the average Ameren customer pays. This rate is also below the cost of service.

Noranda's claims of needing economic relief are unsubstantiated. Reports indicate that their financial scenario includes paying dividends to shareholders and their largest investor is selling their stock without reinvesting back into the smelter.



As a state legislator, these are the types of concerns I would need to fully understand before authorizing the kind of economic relief Noranda is requesting. However, the case is not being considered by the General Assembly, but instead by the PSC, which does not have a history of taking up economic development policy.

Again, I'd like to express my opposition to this rate shift and request that the PSC consider dismissing the case and referring it to the General Assembly.
