This filing is being made to notify the Commission that eVolve Business Solutions, a VoIP provider in Missouri, was merged into Cincinnati Bell Any Distance Inc., a local exchange provider in Missouri, on June 30, 2017. As a result of this merger Cincinnati Bell Any Distance Inc. is now the name of the VoIP provider in Missouri. Cincinnati Bell Any Distance Inc. was granted authority to provide local exchange service in Missouri in 2009 under Case No. 2010-0098.

Customers were provided with the following bill message on their May, 2017 bills "Effective July 1, 2017 Cincinnati Bell will merge its eVolve Business Services entity into Cincinnati Bell Any Distance. This has no impact on the services you purchase from us. Everything remains the same except the name- your eVolve services will now be provided as Cincinnati Bell Any Distance".

Cincinnati Bell Any Distance Inc. is in good standing with the Missouri Secretary of State under Charter F00378717. Attached is a screen shot of the listing on the Missouri Secretary of State site.
