

3. Applicant requests the Missouri Public Service Commission to order a change of electric supplier to the address indicated above.

4. Applicant requested the Commission to order a change of electric supplier
from AmerenUE
to Cuivre River Electric (Current)
(Requested)

5. Applicant requests the Missouri Public Service Commission to order a change of electric provider for the following reasons.* _____

- 1) All surrounding properties are currently served by Cuivre River (EX 1)
- 2) ~~Cuivre has 2 lines and easements bisecting the property (EX 2)~~
- 3) AmerenUE's closest service is 1400' East of the property (EX 3)
- 4) As proposed AmerenUE's service to this property will require:
 - A. Acquisition of Easements from two properties in Flint Hill (EX 4)
 - B. Clearing and ongoing trimming of 1200' of trees (EX 5)
 - C. ~~Drilling of a terminal pole into the waste area of the Landfill~~
(Requiring a permit from the DNR Solid Waste Division) (EX 6)
 - D. ~~Wasatch Inv. would have to provide +/- 600' of conduit and wire~~
to the facility entrance at a cost of \$7,000 to \$8,000 (EX 7)
- 5) The facility requires only 60-100KW/mo or \$100 service/year
- 6) This extension will not serve either the property to the west
(a jurisdictional wet lands) or the farm land to the north
700' away (past our entrance) (EX 8)

6. Applicant has taken the following steps in an attempt to work out electric service problems with the electric service provider: _____

Service was ordered May 25, 2007 for connection on July 1, 2007

Property was finish graded and seeded on July 5, 2007 and fencing has been constructed. AmerenUE is still acquiring the Easements and Permits and has not presented a timetable for service.

Phone calls requesting status are ignored and not returned.

WHEREFORE, Applicant requests the Missouri Public Service Commission to issue an Order which changes the current electric service provider.


