## THE STATE OF MISSOURI'S SUGGESTIONS IN SUPPORT OF PUBLIC COUNSEL'S MOTION TO RECONSIDER THE COMMISSION'S ORDER REGARDING TEST YEAR AND PROCEDURAL SCHEDULE

The State of Missouri (the State), through the Attorney General, respectfully requests that the Commission reconsider its order in this case regarding test year and procedural schedule. The Staff and the Office of Public Counsel, in their respective motions have articulated the bases warranting reconsideration of the Commission's order. The State supports those motions. The State will spare the Commission redundancy other than remind the Commission that using AmerenUE's test year will further delay the point in time where AmerenUE's customers cease financing AmerenUE's overearnings. Public Counsel has estimated the current monthly overearning to be on the order \$20.8 millions dollars, based on an estimated overearnings figure of \$250 million per year. (See OPC's Request for Order Setting Evidentiary Heairng, served September 27, 2001.) That is a huge burden to place on the backs of AmerenUE's consumers. Reconsideration of the Commission's Order and in particular, utilizing the test year OPC and Staff requested could substantially mitigate that burden.
