#### JOINT APPLICATION OF KENNETH JAEGER AND BLUE LAGOON, LLC FOR AN ORDER AUTHORIZING KENNETH JAEGER, TO TRANSFER HIS ASSETS TO BLUE LAGOON, LLC AND ESTABLISHING A RATE FOR BLUE LAGOON, LLC

COMES NOW Blue Lagoon, LLC ("Blue Lagoon"), and Kenneth Jaeger ("Jaeger") (together, the "Joint Applicants") and, for their Joint Application for an Order Authorizing Kenneth Jaeger to Transfer his lagoon, sewer system, easements and rights of way, real estate for spray area and other rights and interest in Blue Lagoon and for the establishment of a Rate ("Application"), state the following to the Missouri Public Service Commission ("Commission").

#### Applicant Kenneth Jaeger

1. Kenneth Jaeger currently owns a lagoon and sewer system located in Ralls County Missouri. Kenneth Jaeger does not have a permit to operate the Lagoon nor has the Missouri Public Service Commission issued a Certificate of Convenience and Necessity.. Kenneth Jaeger is involved in a lawsuit with the state of Missouri and there are two claims pending with the Missouri Public Service Commission. As settlement to this lawsuit and the claims, Kenneth Jaeger has agreed he would transfer ownership of the Lagoon, sewer system, easements and right of ways, real estate for spray area and all other rights of the lagoon and sewer system to Blue Lagoon LLC. Mr. Jaeger knows of no other person or entity to who will be the continuing authority of the sewer system..

2. In compliance with Rule 4 CSR 24-2.060 (1), Kenneth Jaeger provides the information set forth in paragraphs 4-7 hereof.

3. The street address of Kenneth Jaeger is an individual sole proprietor of the lagoon and sewer system with his principal place of business being his home address of 27948 Ted Hunt Road, Unit 2, Los Fresonos, Texas 78566. Mr. Jaeger's mailing address is the same as the address for the place of business set out above. His telephone number is (956) 371-1467 He does not have an electronic mailing address or fax number.

4. Mr. Jaeger is self employed and is in the construction business.

5. Correspondence, communications, and orders and decisions of the Commission that affect Mr. Jaeger are to be mailed to Joe Maxwell, 210 E. Love, Mexico, Missouri 65265.

6. Mr. Jaeger has three pending actions involving himself and the lagoon and sewer system which are the subject of this application. They are:

a. Ralls County Circuit Court Case No. CV805-12CC State of Missouri v. Ken Jaeger;

b. Missouri Public Service Commission Case No. SC-2005-0083 Reierson, et ux. v. Jaeger; and

Jaeger.

c. Missouri Public Service Commission Case No. SC-2005-0099 Hellebusch v.

7. Mr. Jaeger is a sole proprietor and has not registered a fictitious name with the Secretary of State. While Mr. Jaeger formed a Non-Profit Corporation, Blue Lagoon Sewer System, Inc, on May 24, 2004, he did not transfer any assets to the Corporation nor did he do any business in the name of the Corporation or on behalf of the Corporation. Blue Lagoon Sewer System, Inc. (N00590363) has been administratively dissolved. The sewer system has also been referred to as the Lost Valley Lagoon.

8. No annual report or assessment fee is overdue, however, final resolution of the above stated legal actions are still pending.

#### **Applicant Blue Lagoon, LLC**

9. Applicant Blue Lagoon, LLC is a Missouri limited liability corporation is in good standing, with its principal place of business is at 44836 Sheil Lane, Monroe City, Mo. 63456. Its mailing address is the same. In compliance with Rule 4 CSR 240-2.060 (1), Blue Lagoon, LLC provides the information set forth in paragraphs 10-14 hereof.

10. Blue Lagoon, LLC telephone number is also (573)568-2498. Its fax number is (573) 568-2498 and it does not have an e-mail address. A Certificate of Organization, issued by the Missouri Secretary of State on November 7, 2007, Articles of Organization and a Certificate of Good Standing are attached hereto as Exhibit A.

11. Blue Lagoon, LLC was organized to transact any and all lawful business for which a limited liability company may be organized. It is a sole member limited liability company. It's sole member is Alvin Thompson, 44836 Sheil Lane, Monroe City, Mo. 63456.

12. Correspondence, communications, and orders and decisions of the Commission that affect Blue Lagoon, LLC should be sent to Alvin Thompson, sole member, 44836 Sheil Lane, Monroe City, Mo. 63456.

13. Neither the Applicant Blue Lagoon, LLC nor its sole member, Alvin Thompson, have any pending action or final unsatisfied judgment or decision against it from any state or federal agency or court that involves customer service or rates that has occurred within three years prior to the date of the filing of this Joint Application.

14. Applicant Blue Lagoon, LLC does not have any overdue commission annual reports or assessment fees.

#### **Requirements of Rule 4 CSR 240-3.305**

15. Pursuant to Commission Rule 4 CSR 240-3.305, Applicants provide the information in Paragraphs 16 - 21 below.

16. There is not another sewer utility in the area each of the business and residence are dependent upon the sewer system which is the subject of this application.

17. There are more than 10 residents and landowners within the proposed service area. The following is a list of ten of the residents:

- 18. The legal description shall be submitted to the Missouri Public Service Commission after the filing of this application.
- 19. A plat of the proposed service area is attached and marked as Exhibit B.
- 20. The following is the information in satisfaction of Commission Rule 4 CSR 240-3.305 (1) (A) 5:
  - a. Blue Lagoon, LLC is a Missouri Limited Liability Company formed for the purpose of operating an existing sewer system within the proposed service area.
  - b. The lagoon, spray area, mains, manholes, lift station, pump, and piping, are already in place; the remaining part of the system being proposed is to replace the existing irrigation system with a water-reel and pump system. Exhibit C outlines the proposed water-reel and its estimated cost of \$13,249.13. This water-reel is being purchased by Applicant Kenneth Jaeger. The lift station requires that a second pump be installed. Applicant Ken Jaeger is also proposing purchasing the pump for the lift station estimated cost is shown on Exhibit D, in the amount of \$3,500.00. The Applicant Blue Lagoon proposes to establish an additional alarm system which would notify him of any problems by calling his telephone,

Mr. Alvin Thompson has estimated this cost to be \$600.00 for installation. Applicant Blue Lagoon is proposing this cost be established in the regulated rate.

- Exhibit E shows the lagoon, the spray area and the service area as well as b. the engineering supporting the system. Within the service area is approximately 2,115 lineal feet of 8-inch PVC gravity sewer line, a lift station, 13 manholes and 2 additional clean outs. The original development to include the lagoon was purchased for approximately \$104,000.00. The total acres of the development is a little over twenty acres including the lagoon and spray area. The spray area makes up 6.5 acres not including the set back and lagoon. Applicant Ken Jaeger alleges \$75,000.00 of the original purchase price was for the lagoon and related land area. Applicant Ken Jaeger employed Alvin Thompson to install the 8 inch PVC main and 13 manholes the total cost of this construction was approximately \$94,000.00; this cost does not include Applicant Ken Jaeger's labor or the cost of Applicant Ken Jaeger's equipment which was used in the construction of the mains. Applicant Ken Jaeger has expended approximately \$12,000.00 on the sewer systems lift station not including the cost of the proposed second pump..
- c. By the end of the first year, Applicant Blue Lagoon, LLC proposes to have installed the wheel-reel outlined in Exhibit C. The Applicant further proposes to build an equipment storage shed for an estimated \$8,500.00. Applicant Blue Lagoon, LLC is proposing this cost be established in the regulated rate.
- d. The service area includes 26 single family homes, a motel, a camp ground and a convenience store. Approximately 13-15 people reside within the service area on a full time basis. The remainder of the residents are seasonal due to the recreational nature of the Mark Twain Lake Area. 1,069,000 gallons of water was used within the service area in the last 12 months.
- e. There are no current plans for additional connections in the service area, however, the development does allow for as many as 10 more single family homes to be built and added to existing mains. In the engineers irrigation calculations it was estimated that these 10 additional homes would increase the water usage by 3,340 gallons per day. See Exhibit F.
- f. Currently no rate is being charged any of the landowners or residents within the service area. Applicant Blue Lagoon, LLC is proposing a rate equivalent to the water rate currently being charged to the landowners and residents of the service area by Cannon Water Supply District No. 1 of Ralls, Monroe, and Marion Co. Mo. plus \$16.00 a month additional charge per month and an additional \$5.00 per 1,000 gallons over the minimum useage. Applicant Blue Lagoon, LLC is also proposing a \$100.00 connection fee to cover the cost of inspecting the hook up. The proposed fee is based on the amount of water used by the landowner or resident, for standard water meters the Water District rate is \$14.00 for the first 1,000 gallons of water used and \$5.50 for each additional 1,000

gallons. For large meters, the proposed rate would be \$60.00 for the first 6,000 gallons of water used and \$5.50 for each 1,000 gallons thereafter.

- g. Currently no income is generated from the system.
- h. Based on the last twelve months water bills the proposed rate would generate \$21,135.40 per year.
- I. The water usage has been fairly consistent over the last several years and Applicant Blue Lagoon, LLC does not expect there to be a change within the next 3 years.

j.

Applicant Blue Lagoon, LLC proposes a labor rate of \$25.00 per hour and estimates the following:

\* \$6,100.00 labor cost per year for irrigation based on the estimated usage and pumping time required. The proposed pump pumps 100 gallons per minute. Missouri Department of Natural Resources has estimated that 1,200,000 gallons per year must be pumped this equals 200 hours of spray time. The additional 44 hours is for setting up the reel.

\* One trip a week to site for inspection \$520.00 in travel expense pr year and \$1,3000.00 in labor cost,

\* mowing of the lagoon with an annual cost of \$2,150.00. See Exhibit G Applicant Blue Lagoon estimates that the spray area will have to be mowed 6 times per year with an average cost of \$200 per cutting, \$1,200.00 per year.

\* electric cost of \$1,020.00 per year,

\* Liability insurance of \$3,833.33 per year. See Exhibit H.

\* Telephone service would be approximately \$360.00 per year.

\* The Cannon Water Supply District No. 1 of Ralls, Monroe, and Marion Co. Mo. have agreed to manage the billing at a cost of 10% of the billed amount, \$2,113.54 per year.

\* Annual property tax of \$321.88

\* Monthly debt service payments of approximately \$225.00. (72 monthly installments) This is an annual payment \$2,700.00.

\* Fees to Public Service Commission

- k. Applicant Blue Lagoon, LLC anticipates the operating expense to remain the same each of the next three years.
- 1. The assets being transferred are being done so free and clear of all encumbrances and have a value of \$170,000.00, this along with the credit of the owner of Blue Lagoon, LLC allows the applicant to secure the necessary capital to make the proposed improvements and additions to the system. See Exhibit I.
- m. Most of the development has been completed by Applicant Ken Jaegar and will be transferred without any cost to Applicant Blue Lagoon, LLC.
- n. Applicant Blue Lagoon, LLC's owner and sole member, Alvin Thompson, will be the operator of the system. Mr. Thompson has over 40 years of contracting work and sewer system installation experience. He is the contractor who installed and conducted the testing on the system that is the subject of this application. His telephone number is (573) 248-7866.

- o. Mr. Thompson will be responsible for managing the sewer system. His intentions are to contract with Cannon Water Supply District No.1 of Ralls, Monroe and Marion Co. MO. to issue the billing.
- p. There are no management contracts.

21. It is necessary for Blue Lagoon, LLC to be accepted as an authorized continuing authority by the Department of Natural Resources pursuant to 10 CSR 20-6.010 (3) in order for DNR to issue an operating permit to Applicant Blue Lagoon, LLC. No other approval is required.

#### **Requirements of Rule 4 CSR 240-3.310**

22. Pursuant to Commission Rule 4 CSR 240-3.310, Applicants provide the information in Paragraphs 22-28 below.

23. The property is located as part of the Lost Valley Subdivision, (See Exhibit J) and does not require a franchise to operate. Applicant Ken Jaeger has not received a certificate of convenience and necessity.

24. There is not a contract for sale.

25. Blue Lagoon, LLC has adopted the attached Resolution authorizing member Alvin Thompson to proceed with the transfer of the assets subject to the contingencies being met.. See Exhibit K

26. This transfer of assets is not detrimental to the public interest. The residents and landowners need to have a service provider.

27. Until the transfer is approved, Blue Lagoon, LLC does not have any assets or liabilities nor does it have any receipts or expenses.

28. There will not be any impact on the taxes of any of the political jurisdictions in that both Applicants, Ken Jaeger and Blue Lagoon, LLC are private entities.

#### Transaction

29. This transaction and transfer of assets is to be a part of a proposed settlement of the Ralls County Circuit Court Case No. CV805-12CC State of Missouri v. Ken Jaeger; and satisfies the Missouri Department of Natural Resources operating permitting requirement that a continuing authority be established.

30. Applicant Ken Jaeger, purchased the lagoon and development after it was in operation. He then subdivided the development and sold individual lots. The owners of the lots built homes and connected the homes to the existing sewer system. After a complaint was made

to DNR it was discovered that the lagoon and sewer system did not have an operating permit and that much of the system needed to be upgraded for an operating permit to be issued by DNR.

31. Following over two years of development and legal action, DNR has agreed to issue an operating permit so long as a continuing authority is established. Because of the problems associated with the Ralls County Circuit Court Case the State of Missouri, by and through the Missouri Attorney General, believe it is in the best interest of the landowners and residents served by the service area to have someone other than Applicant Ken Jaeger to be the continuing authority. Therefore this joint application has been prepared and filed.

32. Applicant Ken Jaeger has agreed to transfer the assets to Applicant Blue Lagoon, LLC at no cost to Applicant Blue Lagoon, LLC; to forfeit all rights to income and profits from the lagoon and sewer system and to pay \$25,000.00 in penalties as ordered by the Ralls County Circuit Court.

33. Applicant Ken Jaeger has accepted these terms based on the settlement agreement with the State of Missouri and has agreed to continue with the transfer so long as the Missouri Public Service Commission, State of Missouri, Missouri Department of Natural Resources release him from all other claims not otherwise contained in the court ordered settlement. Such settlement shall be sent to the Missouri Public Service Commission as part of this application upon its execution.

34. Applicant Blue Lagoon, LLC has agreed to accept the transfer of the assets and sewer system so long as Missouri Department of Natural Resources agrees that upon Applicant Blue Lagoon, LLC being established as the continuing authority they will issue an operating permit and all claims against the property and sewer system which is th subject of this Application have been released to the satisfaction of Blue Lagoon, LLC. Applicant Blue Lagoon, LLC further reserves the right to refuse the transfer until an acceptable sewer rate is established.

#### **Notice to Customers**

35. In conjunction with the filing of this joint application, Blue Lagoon, LLC is providing notice of the application and proposed rates to the landowners and residents of the sewer system. A copy of the notice shall be filed with the commission within 10 days after the case is opened for consideration. Such notice will invite the customers to submit comments regarding this application.

WHEREFORE, Joint Applicants Ken Jaeger and Blue Lagoon, LLC pray that the Commission enter its order:

(a) authorizing Ken Jaeger to transfer all of its sewer system assets associated with the Lost Valley Subdivision to Blue Lagoon, LLC;

- (b) issuing a certificate of convenience and necessity to Blue Lagoon, LLC,
- (f) establishing the rates that Blue Lagoon, LLC requested it be allowed to set,

(g) upon issuing a certificate of convenience and necessity dismissing the claims contained in the two pending cases before the Commission, Missouri Public Service

Commission Case No. SC-2005-0083 Reierson, et ux. v. Jaeger; and Missouri Public Service Commission Case No. SC-2005-0099 Hellebusch v. Jaeger.

(g) granting any other and further relief the Commission deems necessary and appropriate.
