**COMES NOW** Missouri Retailers Association (MRA) and for its Position Statement in this case states:

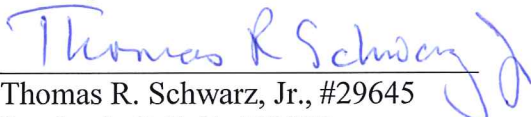
1.     The MRA takes a position only on the issues designated as 25.C and 25.E.
2.     On Issue 25.C, "How should any rate increase be collected from the several customer classes?" The MRA's position is that the Commission should reduce the proportion of Ameren Missouri's revenue requirement allocated to the small general service, large general service and small primary service customer classes.
3.     On Issue 25.E, "What should the small general service class customer charge be (single-phase and three-phase)?" the MRA takes the position that the Commission should authorize no change in the current customer charge.

**WHEREFORE**, having apprised the Commission of its position on the issues in this case, the MRA asks the Commission to order accordingly in its Report and Order in this case.

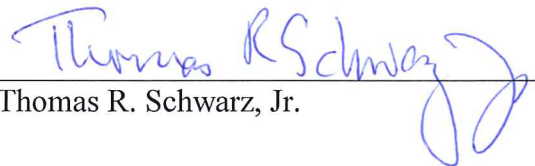
