AFFIDAVIT

I, Patricia S. Lewis, a natural person, do hereby swear and affirm that I am an officer of Charter Communications, Inc., the manager of Charter Advanced Services (MO), LLC (“Applicant”), and that the following statements are true and correct to the best of my knowledge and belief:

(1) The location of the principal place of business and the names of the principal executive officers of the Applicant: Applicant’s principal place of business is 12405 Powerscourt Drive, St. Louis, Missouri 63131. Applicant is managed by Charter Communications, Inc. The principal executive officers of Charter Communications, Inc. are Thomas M. Rutledge (President and Chief Executive Officer), John Bickham (Chief Operating Officer), Tom Adams (Executive Vice President, Field Operations), Jim Blackley (Executive Vice President, Engineering and Information Technology), Don Detampel (Executive Vice President, Technology and President, Commercial Services), Jonathan Hargis (Executive Vice President and Chief Marketing Officer), Kathleen Mayo (Executive Vice President, Customer Operations), Robert Quicksilver (Executive Vice President and Chief Administrative Officer), Scott Weber (Executive Vice President, Network Operations), Christopher L. Winfrey (Executive Vice President and Chief Financial Officer), Richard R. Dykhouse (Senior Vice President, General Counsel and Corporate Secretary), Kevin D. Howard (Senior Vice President, Controller and Chief Accounting Officer), and James M. Heneghan (President, Charter Media).;

(2) Each exchange, in whole or in part, of a local exchange company in which the Applicant proposes to provide interconnected voice over Internet protocol service:

AT&T Exchange Areas (Antonia, Benton, Bismarck, Bonne Terrer, Camdenton, Cape Girardeau, Cedar Hill, Chaffee, Charleston, Chesterfield, Creve Coeur, DeSoto, East Prairie, Eldon, Eureka, Farmington, Fenton, Festus-Crystal City, Flat River, Fredericktown, Fulton, Gravois Mills, Gray Summit, Hannibal, Harvester, Herculaneum-Pevely, High Ridge, Hillsboro, Imperial, Jackson, Kirkwood, Knob Noster, Ladue, Lake Ozark-Osage Beach, Leadwood, Lilbourn, Manchester, Marston, Maxville, Mehlville, Mexico, Moberly, Montgomery City, Morehouse, New Madrid, Oakville, Oran, Pacific, Pond, Sappington, Scott City, Sedalia, Sikeston, St. Charles, St. Clair, St. Louis, Union, Valley Park, Versailles, Washington, and Wellsville), Embarq Exchanges (Clinton and Warrensburg), CenturyTel Exchanges (Bourbon, Centralia, Columbia, Cuba, Dardenne, Foristell, Moscow Mills, O'Fallon, St. Peters, St. James, Troy, Warrenton, Wentzville, and Wright City);

(3) That the Applicant is legally, financially, and technically qualified to provide interconnected voice over Internet protocol services;

(4) That the Applicant is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of interconnected voice over Internet protocol services;

(5) That the Applicant will charge and collect from its end user customers on interconnected voice over Internet protocol service, and remit to the appropriate authority, fees and surcharges in the same manner as are charged and collected upon end user customers of local exchange telecommunications service and remitted by local exchange telecommunications companies, including but not necessarily limited to:

(a) Telecommunications programs under section 209.255, RSMo;

- (b) Missouri universal service fund under section 392.248;
- (c) Local enhanced 911;
- (d) Any applicable license tax;

(6) That the Applicant will remit the annual assessment imposed by the Commission under section 386.370, RSMo;

(7) That the Applicant will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission;

(8) That the Applicant has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. Consumer complaints may be directed to:

1-888-438-2427 for Residential Customer Support and to 1-800-314-7195 for Business Customer Support;

and


(9) The Applicant's interconnected voice over Internet protocol service meets the following criteria:

- (a) Enables real-time, two-way voice communications;
- (b) Requires a broadband connection from the user's location;
- (c) Requires Internet protocol-compatible customer premises equipment;

and

(d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.
