**NOTICE REGARDING NONSIGNATORY PARTIES**

COME NOW Laclede Gas Company (“Laclede”) and St. Louis Natural Gas Pipeline, LLC (“SLNGP”) and files this Notice Regarding Nonsignatory Parties, and in support thereof, state as follows:

1. On September 30, 2011, Laclede, on behalf of itself and SLNGP, filed a Stipulation and Agreement (the “Stipulation”) resolving all issues in the above referenced complaint case.

2. Paragraph 7 of the Stipulation states that the nonsignatory parties to this case (Staff and Public Counsel) have had an opportunity to review the Stipulation and Agreement and expressed no objection to its contents. While Laclede had shared a previous draft of the settlement agreement with the nonsignatory parties, such parties have neither seen the final version of the Stipulation nor expressed any opinion regarding its contents. Laclede and SLNGP regret this oversight.

3. The nonsignatory parties should retain their right to object to the Stipulation pursuant to 4 CSR 240-2.115.
