**ATMOS ENERGY CORPORATION'S
NOTICE OF INTENDED CASE FILING**

COMES NOW Atmos Energy Corporation ("Atmos") and, pursuant to Missouri Public Service Commission ("Commission") Rule 4 CSR 240-4.020(2), respectfully submits its Notice of Intended Case Filing ("Notice") regarding its next Purchased Gas Adjustment ("PGA") tariff filing. In support of its Notice, Atmos states as follows:

1. Atmos is a corporation duly organized, validly existing and in good standing in all respects under the laws of the State of Texas and Commonwealth of Virginia, with its principal office and place of business at 5430 LBJ Freeway, Dallas, Texas 75240. Atmos is authorized to conduct business in the State of Missouri and is engaged in the distribution and retail sale of natural gas in those areas of Missouri certificated to it by the Commission.

2. A certified copy of Atmos' certificate of authority to do business as a foreign corporation in Missouri was filed with the Commission in Case No. GR-2006-0387. Said document is incorporated herein by reference in accordance with 4 CSR 240-2.060(1)(G) and made a part hereof for all purposes. Atmos is a "gas corporation" and a "public utility" as those terms are defined in Section 386.020 of the Revised Statutes of Missouri and as such is subject to the jurisdiction of the Commission as provided by law.

3. Atmos may have pending actions against it involving customer service or rates having occurred within three (3) years from the date of this Application in certain of the jurisdictions in which it provides service, but none in Missouri. Atmos has no annual report or assessment fees that are overdue.

5. Commission Rule 4 CSR 240-4.020(2) provides in part as follows:

Any regulated entity that intends to file a case likely to be a contested case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such a case. Such notice shall detail the type of case and issues likely to be before the commission.

6. Pursuant to its approved tariffs, in addition to its required Winter PGA filing made between October 15 and November 4 of each calendar year,¹ Atmos also is permitted to make three (3) Optional PGA filings.

7. At this time, it is unclear when Atmos will be making its next Optional PGA filing. In making such filing, Atmos does not intend to create a contested case. It does not appear that Atmos' PGA filings are the type of case intended to be covered by the above-referenced rule. Nevertheless, Atmos is filing this Notice out of an abundance of caution.

¹ Atmos submitted its Winter PGA filing on October 17, 2011, which was approved on an interim basis subject to refund by the Commission's Order Approving Interim Rates issued October 26, 2011, effective November 1, 2011, in Case No. GR-2011-0161.

WHEREFORE, Atmos Energy Corporation respectfully submits its Notice of Intended Case Filing as set forth herein.
