Dear Judge Roberts

On March 4, 2002, Comcast Business Communications, Inc , d/b/a Comcast Long Distance (“CBC”), by its attorneys, filed with the Missouri Public Service Commission (“Commission”) a Notification regarding the transfer of ownership and control of CBC’s ultimate parent, Comcast Corporation (“Comcast”), and thus also CBC, to a newly-created ultimate parent, AT&T Comcast Corporation. This letter is to advise the Commission that the transactions that were the subject of the Notification have been completed.

As part of the consummation of the transactions, the names of certain parties were modified, but not that of CBC. AT&T Comcast Corporation is now known as Comcast Corporation, and is the ultimate parent company of CBC. The former Comcast Corporation was renamed Comcast Holdings Corporation. A chart describing the completed transaction before and after the name changes is attached hereto as *Exhibit A*. Because both Comcast Corporation and Comcast Holdings Corporation function only as holding companies, they are not required to qualify to do business within the State of Missouri under their new names. As described in the Notification, the change in control of CBC’s ultimate parent is transparent to the public as CBC continues to provide the same services to customers in Missouri, pursuant to the same authorization.

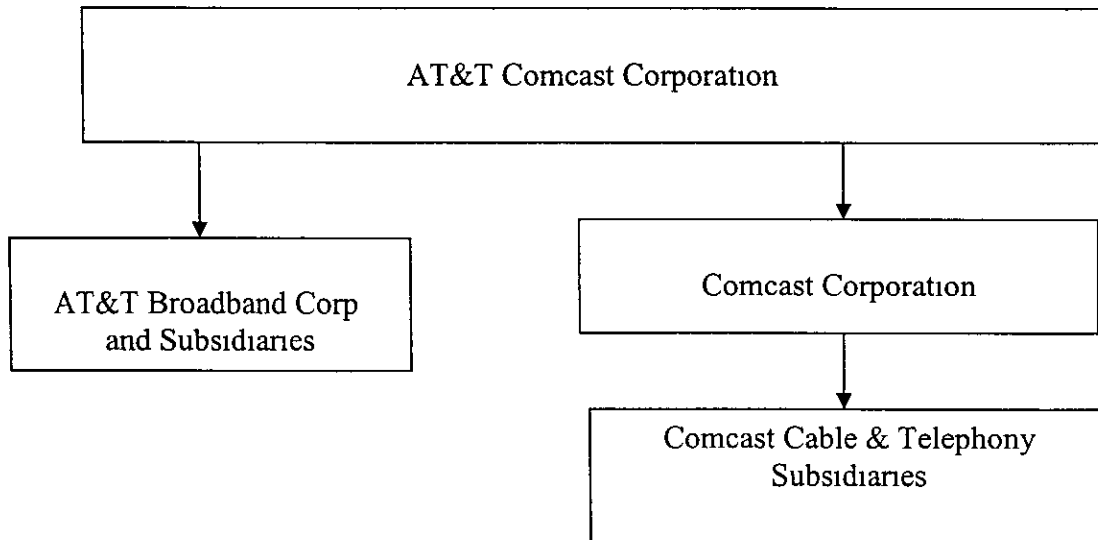
