MOTION FOR EXPEDITED TREATMENT

COMES NOW Central Rivers Wastewater Utility, Inc. (Central Rivers or Company), and, in accordance with Missouri Public Service Commission (Commission) Rules 4 CSR 240-2.080(14) and 4 CSR 240-2.065(2), moves the Commission for expedited treatment of Central Rivers' tariff sheet filed on January 19, 2015:

1. On January 7, 2015, the Commission issued its Order Approving Stipulation and Agreement (effective January 17, 2015). In that Order, among other things, the Commission ordered Central Rivers to file a tariff sheet consistent with the Order no later than January 19, 2015.

2. Central Rivers has filed a tariff sheet in order to comply with the Commission Order (a copy of which is provided as **Appendix A**). This tariff sheet carries a proposed effective date of February 18, 2015, and was assigned tracking number YS-2015-0246.


3. Central Rivers seeks the Commission's order allowing the proposed tariff sheet to go into effect on February 1, 2015.

4. Central Rivers filed the rate case request that forms the basis for this case on March 11, 2014. The Commission's Order Approving Stipulation and Agreement has authorized a rate increase for Central Rivers. Thus, the tariff sheet is being filed in compliance with Commission Order. Because Central Rivers bills on a monthly basis, a February 1, 2015 effective date will allow Central Rivers to transition to the new rate without the need for pro rating its bills.

5. Lastly, granting this Motion will avoid further delay in regard to the rate relief that the Commission has found to be just and reasonable. As such, Commission action as requested will be consistent with the public interest as established by the General Assembly and Commission order. The subject tariff sheet and this Motion have been filed as soon as possible after the issuance of the Commission's Order Approving Stipulation and Agreement.

WHEREFORE, for the foregoing reasons, Central Rivers respectfully requests the Commission to grant Central Rivers' Motion for Expedited Treatment and approve Central Rivers' proposed tariff sheet (Tracking No. YS-2015-0246) to be effective on February 1, 2015.
