ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE TARIFF

On September 17, 1998, the Commission issued its Order Granting Certificate to Provide Basic Local Telecommunications Services and Order Acknowledging Change of Name. The Commission's order directed Logix Communications Corporation (Logix) to file tariff sheets within 30 days after the effective date of a Commission order approving an interconnection agreement which permitted Logix to provide services.

On January 7, 1999, Logix filed a Motion for Extension of Time to File Tariff with the Commission. In its motion, Logix indicated that the Commission approved an interconnection agreement with Southwestern Bell Telephone Company (SWBT) in Case No. TO-99-101 on December 1, 1998. That order became effective on December 11. According to the directions in the Commission's September 17th order, the applicant's proposed tariff sheets should have been filed on January 11, 1999. Logix stated that despite its best efforts to finalize its proposed tariff for filing by January 11, it was unable to do so. Logix estimated that it believed that it would be able to file its proposed tariffs on or before March 12. Logix has requested an order of the

Commission granting its Motion for Extension of Time to File Tariff permitting Logix to file its proposed tariff on or before March 12. No objections were received from any of the other parties. As no party objected this request, the Commission will extend the time for Logix to file its tariff to March 12.

IT IS THEREFORE ORDERED:

1. That this Motion for Extension of Time to File Tariff filed by Logix Communications Corporation f/k/a Dobson Wireless, Inc. on January 7, 1999 is granted. Logix Communications Corporation is ordered to file its proposed tariff sheets on or before March 12, 1999.

2. That this order shall become effective on February 19, 1999.
