## APPLICANT UNIVERSAL TELECOM, INC.'S REQUEST FOR SUSPENSION OF PROCEDURAL SCHEDULE OR EXTENSION OF TIME TO FILE PROPOSED PROCEDURAL SCHEDULE

COMES NOW Applicant Universal Telecom, Inc., ("UTI"), by and through its undersigned counsel, and respectfully requests, with the consent of the other parties, that the procedural schedule be suspended or an additional two weeks be provided for the final review and approval of the Stipulation.
