## SOUTHWESTERN BELL TELEPHONE COMPANY'S APPLICATION TO INTERVENE

Southwestern Bell Telephone Company, pursuant to §386.420 RSMo (1994) and 4 CSR 240-2.075, respectfully seeks to intervene in this proceeding and states:

- 1. Southwestern Bell is a Missouri corporation duly authorized to conduct business in Missouri with its principal Missouri office at One Bell Center, St. Louis, Missouri 63101. Southwestern Bell is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri as each of those phrases are defined in §386.020 RSMo (1994).1

In this proceeding, Telistar Communications, LLC (Telistar) seeks a certificate of service authority to provide basic local telecommunications services in exchanges currently served by GTE, Sprint and SWBT. Telistar seeks classification as a competitive company and to receive a lesser degree of regulation as permitted under Sections 392.361 and 392.420 RSMo. (1994) and the waiver of various statutory provisions and Commission rules.

All statutory cites are to the Missouri Revised Statutes.

- 4. Southwestern Bell seeks to intervene in this proceeding because it has a direct interest in the Commission's decision on Telistar's Application. Southwestern Bell is authorized to provide basic local and local exchange telecommunications services within the State of Missouri. Pursuant to tariffs on file with the Commission, Southwestern Bell is authorized to provide the type of services within the State of Missouri that Telistar seeks to provide. Telistar in this certification proceeding has requested service authority in exchanges served by Southwestern Bell, GTE Midwest Incorporated and Sprint Missouri, Inc. - 6. Granting of this intervention will be in the public interest because Southwestern Bell will bring to this proceeding its expertise and experience as a telecommunications provider.
