MOTION FOR TEMPORARY WAIVER
OF REQUIREMENT FOR INTERCONNECTION AGREEMENT AND TARIFF

Comes now Allied Riser of Missouri, Inc. (hereinafter "Allied"), by Hendren and Andrae, L.L.C., Richard S. Brownlee, III, and for its Motion for Temporary Waiver of Requirement for Interconnection Agreement and Tariff states:

1. Allied was granted a Certificate to Provide Basis Local Service and Interexchange Telecommunications Services in the State of Missouri by the Commission Order dated September 7, 2000.

2. The Order stated, inter alia the following:

"7. That Allied Riser of Missouri, Inc., shall file tariff sheets with a minimum 45-day effective date reflecting the rates, rules, regulations and the services it will offer within 30 days after the effective date of a Commission order approving an interconnection agreement that will allow Allied to provide services."

(Report and Order, P. 10-11)

"Allied's certificates shall become effective when its' tariffs become effective." (Report and Order, p. 7).

3. The result of the Commission's Order as set forth in paragraph 2 is that Allied's Certificate is not effective until an Interconnection Agreement and Tariff are approved by the Commission.


4. Allied's present business plan is to only provide high speed internet access to customers in Missouri, thus it has no present need for an interconnection agreement or tariff.

5. Allied fully understands that before any basic local service or interexchange service is provided in Missouri, it will have on file an approved interconnection agreement and tariff.

6. Southwestern Bell Telephone Company (SWBT) has no objection to the relief requested in this Motion.

WHEREFORE, Allied Riser of Missouri, Inc., requests a temporary waiver of the requirement for the filing of an interconnection agreement and tariff, and further requests that its Certificate be presently approved, conditioned that it will file and have approved an interconnection agreement and tariff before it initiates basic local service of interexchange service in the State of Missouri.




