CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW Nationwide Professional Teleservices, LLC ("NPT"), through its undersigned counsel, and pursuant to 4 CSR 240-2.060 and §392.410(5), RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariff. In support of its Application, states as follows:

1. Nationwide Professional Teleservices, LLC was organized as a limited liability company under the laws of the State of Florida on August 5, 2004. The Applicant's principal office is located at:

A copy of Applicant's Articles of Organization and Certificate of Authority to transact business in Missouri were filed in Case No. XA-2005-0130 and are incorporated herein by reference. NPT's certificate of authority to do business from the Missouri secretary of state was provided in Case No. Case No. XA-2005-0130. Pursuant to 4 CSR 240-2.060(G), NPT requests that the certificate and registration be incorporated by reference herein.

2. NPT does not currently have any customers in the state of Missouri and, as its business plans have changed, NPT no longer intends to provide telecommunications

service in Missouri. Accordingly, NPT customer notification is not necessary and there is no customer impact associated with approval of this petition.

3. NPT does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application. NPT does not, to the best of its knowledge, have any overdue annual reports or assessment fees.

5. Cancellation of NPT' Certificate of Service Authority and tariffs is not detrimental to the public interest. The public will not be harmed by NPT' withdrawal because, as stated above, NPT does not provide any telecommunications services to customers in Missouri, and thus, no customers will be affected. Furthermore, there are

many other alternative telecommunications providers from whom Missouri residents can purchase interexchange telecommunications services.



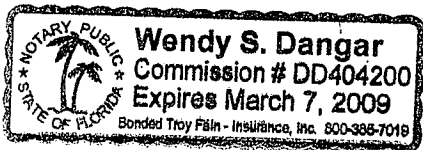


