3. In this proceeding, Adelphia Business Solutions Operations, Inc. (Adelphia) seeks a certificate of service authority to provide basic local telecommunications services in exchanges currently served by SWBT, GTE Midwest, Inc. (GTE) and Sprint of Missouri (Sprint). Adelphia seeks classification as a competitive company and to receive a lesser degree of regulation as permitted under Sections 392.361 and 392.420 RSMo. (1994) and the waiver of various statutory provisions and Commission rules.
