

COMES NOW Applicant Universal Telecom, Inc., ("UTI"), by and through its undersigned counsel, and respectfully requests an extension of time to file the proposed procedural schedule requested in the Commission's Order dated May 26, 2000. The proposed procedural schedule requested by the Commission is due June 26, 2000.
