MOTION TO OPEN DOCKET AND CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Docket and Cancel Certificate of Service Authority, respectfully states as follows:

- 1. On July 8, 1997, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide basic local and local exchange telecommunications service to Local Fone Service, Inc. (Local Fone) in Case No. TA-97-411. According to the Order Granting Certificates, Local Fone's certificate would become effective when the company's tariff became effective. Local Fone does not have an effective tariff in place. The Order Granting Certificates also states that Local Fone is subject to all applicable statutes and Commission rules including the requirement to file an annual report.
- 2. Local Fone did not file an annual report for 1998. Additionally, Local Fone's 1999 annual report form was returned by the post office as undeliverable. The Staff contacted the Missouri Secretary of State's office and was informed that Local Fone was administratively dissolved by the Missouri Secretary of State on August 31, 1998, due to its failure to file an annual report.
- 3. Local Fone has not filed a formal request to cancel its certificate. However, the Staff believes that Local Fone has violated the terms of its certificate by its failure to file an

annual report. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 1999), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no part requests such a hearing. <u>State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Comm'n</u>, 776 S.W.2d 494, 496 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of Local Fone.
