**STAFF'S CORRECTIONS FOR FILINGS**

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through Counsel, and respectfully requests the Missouri Public Service Commission take notice of the following corrections to the August 26, 2008 Unanimous Agreements filed in the above referenced cases:

1. The title of the pleadings in SR-2008-0267 and SR-2008-0268 read Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request. Instead, each pleading should have been titled Unanimous Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request.
2. In paragraph two of the SR-2008-0267 and SR-2008-0268 pleadings, 4 CSR 240-3.635, the Commission's rule on Water Utility Small Company Rate Increase Procedure is cited. The paragraph should cite section 4 CSR 240-3.330, the Commission's rule on Sewer Utility Small Company Rate Increase Procedure.

3. Paragraphs four of the SR-2008-0267 and SR-2008-0268 pleadings reference the filing of the July 3, 2008 Company/Staff Agreement Regarding Disposition of Small Water Company Revenue Increase Request. “Water” should be replaced with “Sewer.”
4. Paragraphs eleven of the SR-2008-0267 and SR-2008-0268 pleadings reference Appendix A as the Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request. “Water” should be replaced with “Sewer.”
5. Paragraphs twelve of the SR-2008-0267 and SR-2008-0268 pleadings reference the Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request. The pleadings should reference the Unanimous Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request.

**WHEREFORE,** Counsel for Staff respectfully submits the above corrections for the August 26, 2008 Unanimous Agreements submitted in the above referenced cases.
