On April 19, 2000, Pathnet, Inc. (Pathnet or Company), a competitive interexchange carrier (IXC), filed an Application for Authority to offer Interexchange and Nonswitched Local Exchange Services, which was granted by the Commission on June 19, 2000. On August 14, 2000 Pathnet requested that the date by which the Company's proposed tariff was to be filed be extended to August 21, 2000. On August 16, 2000, the Commission issued an Order Directing Filing and August 22, 2000 Pathnet filed a Motion for Leave to File Out of Time. Pathnet filed its proposed IXC tariff on August 23, 2000 which has an effective date of October 7, 2000. The effective date has not been extended.

The Telecommunications Department Staff has examined Pathnet's proposed IXC tariff and requested substitute sheets which were filed on September 20 and 22, 2000. Staff has found that the proposed tariff complies with PSC rules and applicable statutes, offers only private line services, proposes ICB pricing and uses standardized ICB text. Rate structures are similar to those of similar carriers, and the waivers requested match those in the Application, Notice, and Order Granting Certification. Standardized promotional language is present in the tariff. There have been no interventions.

Staff has examined the proposed filing and recommends approval. Staff is not aware of any other filing which would affect or be affected by the filing.
